

## **RESOLUTION 2003-1**

### **A RESOLUTION ADOPTING 68 IAC 4 FOR PUBLICATION AS PROPOSED RULES**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. The Commission began the process of readopting 68 IAC 4 in January of 2002 through publication of a Notice of Intent pursuant to IC 4-22-2.5-2. 68 IAC 4 was scheduled to expire on January 1, 2003 if it was not readopted. The Commission received a request for separate consideration of this 68 IAC 4 from the re adoption process.
2. This request requires the Commission to separately consider 68 IAC 4 and to begin the complete promulgation process provided in IC 4-22-2. The Commission staff began this process in August of 2002, but could not complete the process in time for the anticipated expiration date.
3. Pursuant to statute, the Commission staff requested that the Governor's Office issue an Executive Order extending the expiration date of 68 IAC 4 to January 1, 2004.
4. Completion of the promulgation process to adopt these rules will take approximately four (4) to six (6) months.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to all applicants, licensees, persons who do business with an applicant or licensee, and persons who are patrons of a Riverboat Gambling Operation.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this RESOLUTION.

#### **SECTION 3. ADOPTION OF THE PROPOSED RULES.**

The Commission adopts Article 4 of Title 68 in its current form for publication as proposed rules, in anticipation of completing the promulgation process required by IC 4-22-2.5 and IC 4-22-2.

Article 4      Corporations

**SECTION 4. EFFECTIVE DATE.**


This RESOLUTION is effective immediately.

**SECTION 5. EXPIRATION DATE.**

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.
