

## **RESOLUTION 2003-55**

### **A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIER'S LICENSE**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. On January 10, 2003, by RESOLUTION 2003-4, the Commission renewed the Supplier's License of Midwest Game Supply Company ("Midwest") for the period of January 27, 2003 through January 26, 2004.
2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually along with the payment of a Five Thousand Dollar (\$5,000) renewal fee.
3. On October 29, 2003, the Commission received a call from Linda Sohm, owner of Midwest. She requested the ability to pay the Five Thousand Dollar (\$5,000) renewal fee on or about December 15, 2003 due to the fact that the Commission has requested Midwest submit the renewal fee 60 days before the expiration of their license, instead of the typical thirty (30) day request required 68 IAC 2-2-8.
4. On November 3, 2003 the Commission received the annual renewal form requesting the renewal of Midwest's Supplier's License.
5. The above-named Supplier Licensee has requested renewal of licensure. The renewal will be conditioned upon payment of the renewal fee by December 15, 2003. If payment for the renewal fee is not received as directed by the Commission staff, the license will be subject to non-renewal or revocation.
6. The Commission has determined that the above-named Supplier Licensee remain in compliance with IC 4-33.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to Midwest Game Supply Company.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF RENEWAL OF SUPPLIER'S LICENSE.**

The Commission hereby grants the renewal of the Supplier's License issued to the supplier listed below on the conditions that the Five Thousand Dollar (\$5,000) renewal fee is paid by December 15, 2003 and that any outstanding background investigation fees are paid as directed by the Commission staff. The Supplier's License will be valid for a period of one (1) year from the date of issuance.

MIDWEST GAME SUPPLY COMPANY

**SECTION 4. CONDITIONS PLACED ON THE SUPPLIER'S LICENSE.**


The Supplier Licensee must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the Five Thousand Dollar (\$5,000) renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.

**SECTION 5. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.


