

RESOLUTION 2005-10

A RESOLUTION CONCERNING THE RENEWAL OF THE SUPPLIER'S LICENSE HELD BY GAMECASH, INC.

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. GameCash, Inc. ("GameCash") was issued a temporary supplier's license on December 17, 1996 and a permanent supplier's license on February 26, 1999. The license was renewed annually, with the most recent renewal on February 26, 2004.
2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a supplier's license must be renewed annually.
3. GameCash has requested a renewal of licensure and the renewal fee has been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.
4. On or about October 4, 2004, Certegy, Inc. ("Certegy") submitted an application for approval to obtain ownership interests in GameCash, Inc. The Commission's Background Investigation Unit is currently conducting an investigation pursuant to the transfer application. The Commission staff has allowed Certegy to continue operating pending the completion of their background investigation and approval of the transfer from the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to GameCash, Inc. and Certegy, Inc.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

1. The renewal of GameCash's supplier's license is hereby conditioned upon the completion of the background investigation of Certegy and the Commission's approval of the transfer of ownership.

2. Certegy will be responsible for paying any background investigation fees associated with the Commission's investigation. If payment is not received as directed by Commission staff, the supplier's license will be subject to revocation.
3. In the future, if Certegy wishes to renew its supplier's license, it must request renewal of the supplier's license at least thirty (30) days before the expiration of the license and pay the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.

SECTION 4. GRANT OF RENEWAL OF SUPPLIER'S LICENSE.

The Commission hereby grants the renewal of GameCash's supplier's license subject to the conditions stated in Section 3 of this Resolution. The renewed supplier's license will be valid for a period of one (1) year from the date of issuance. Failure on the part of GameCash or Certegy to meet the conditions set forth in this Resolution or complies with IC 4-33 or rules promulgated thereunder will result in appropriate Commission action.

SECTION 5. EFFECTIVE DATE.

This Resolution is effective immediately.
