

## **RESOLUTION 2006-31**

### **A RESOLUTION GRANTING THE EXECUTIVE DIRECTOR THE AUTHORITY TO GRANT TEMPORARY SUPPLIER'S LICENSES**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

1. Proposed Rule #05-199(F) amends 68 IAC 12-1, which outlines general provisions for surveillance systems required to be maintained and utilized by Indiana's riverboat casinos. Pending final promulgation of Proposed Rule #05-199(F), new provisions will be added to 68 IAC 12-1 and existing provisions of 68 IAC 12-1 will be amended in order to detail the minimum requirements for the use of digital video systems by riverboat licensees and operating agents.
2. Riverboat licensees are seeking out suppliers of digital equipment in order to convert the surveillance systems of their riverboats to a digital format.
3. Due, in part, to an anticipated influx of new applications for supplier's licenses it would be in the best interest of the Commission and the licensees to delegate the authority to issue temporary supplier's licenses to the Executive Director.
4. The submission of applications for a supplier's license, along with the completion of a preliminary investigation, usually do not coincide with Commission meetings. Due to the length of time that may elapse between Commission meetings and the unpredictable timing of the issuance of temporary supplier licenses, it would be more expeditious and efficient to delegate the authority to issue temporary supplier's licenses to the Executive director.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION,  
THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1: SCOPE**

This resolution applies to all applicants for a supplier's license.

#### **SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

#### **SECTION 3: GRANT OF AUTHORITY TO EXECUTIVE DIRECTOR TO ISSUE TEMPORARY SUPPLIER'S LICENSES.**

Recognizing the need to issue temporary supplier's licenses prior to scheduled meetings of the Commission, the Commission hereby grants the Executive Director the authority to issue a temporary supplier license to any supplier license applicant upon a determination by the Executive Director that a preliminary investigation has been completed and does not reveal information that would deem an


applicant unsuitable for licensure. The Executive Director may place conditions on the issuance of a temporary supplier's license in accordance with IC 4-33 and 68 IAC. Each issuance of a temporary supplier's license by the Executive director shall be reported to the Commission at the next scheduled business meeting. The temporary supplier's license will remain valid until the date that the permanent supplier's license is issued or until the temporary supplier's license is withdrawn pursuant to 68 IAC 2-2.

**SECTION 4: EFFECTIVE DATE**

This resolution is effective immediately.
