

**ORDER 2011-54**

**ORDER OF THE INDIANA GAMING COMMISSION  
CONCERNING THE RENEWAL OF SUPPLIER'S LICENSES**

In accordance with and subject to Indiana Code 4-33, Indiana Code 4-35, and 68 IAC 2-2 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") has previously issued permanent supplier's licenses to: (1) AC Coin, Inc. (2) Bally Gaming (3) Data Financial, Inc. (4) DEQ Systems Corp. (5) Elektroncek D.D. (6) IGT (7) Incredible Technologies, Inc. (8) Midwest Game Supply Co. (9) Patriot Gaming and Electronics, Inc. (10) TCS John Huxley Europe, Inc. (11) WMS Gaming Inc.

A supplier's license is valid for a period of one (1) year and in accordance with IC 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500) as an annual renewal fee. Each of these licensees has requested renewal of licensure and paid the renewal fees. The Commission has determined that the above-named supplier licensees remain in substantial compliance with IC 4-33 and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** renewal of the licenses of each of the suppliers for a period of one year as specified below:

- 1) AC Coin, Inc. : valid February 26, 2011 through February 25, 2012
- 2) Bally Gaming, Inc.: valid March 30, 201 through March 29, 2012
- 3) Data Financial, Inc.: valid May 04, 2011 through May 03, 2012
- 4) DEQ Systems Corp.: valid March 19, 2011 through March 18, 2012
- 5) Elektroncek D.D.: valid March 19, 2011 through March 18, 2012
- 6) IGT: valid January 27, 2011 through January 26, 2012
- 7) Incredible Technologies Inc.: valid March 02, 2011 through March 01, 2012
- 8) Midwest Game Supply Co.: January 27, 2011 through January 26, 2012
- 9) Patriot Gaming and Electronics, Inc.: valid March 30, 201 through March 29, 2012
- 10) TCS John Huxley Europe Ltd.: valid March 19, 2011 through March 18, 2012
- 11) WMS Gaming Inc.: valid March 17, 2011 through March 16, 2012

Each licensee must notify the Commission of its desire to be considered for a subsequent license renewal at least thirty (30) days before the expiration of the license.
