

RESOLUTION 2013-172
A RESOLUTION ADOPTING LSA DOCUMENT #12-584 AS A FINAL RULE

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under Indiana Code (“IC”) 4-33-4 and IC 4-35-4.

The Commission has considered the following factors:

1. The Commission began promulgation of the attached LSA Rule Document #12-584 under IC 4-22. A Notice of Intent to adopt LSA Rule Document #12-584 was posted at DIN: 20121031-IR-068120584NIA on the *Indiana Register* website on October 31, 2012. An Administrative Rules Oversight Committee Notice was posted at DIN: 20130703-IR-068120584ARA on the *Indiana Register* website on July 3, 2013. The Indiana Register posted the proposed rule at 20130522-IR-068120584PRA on the *Indiana Register* website on May 22, 2013.
2. The Commission held a public hearing for this rule on August 12, 2013, at 10 a.m. in the offices of the Indiana Gaming Commission, Indianapolis, Indiana, in compliance with IC 4-22. There were no attendees and no public comments at the public hearing. The Commission received no public written comments. The fiscal impact statements have all been made available to the Commission. The Commission has also considered the transcript from the public hearing.
3. Following the adoption of the attached rule document as a final rule, the final rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION,
THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1: SCOPE

This resolution applies to all persons subject to the authority granted to the Commission by the General Assembly in IC 4-33-4 and IC 4-35-4.

SECTION 2: DEFINITIONS

The definitions set forth in IC 4-33 and IC 4-35 and 68 IAC apply to this resolution.

SECTION 3: ADOPTION OF FINAL RULES

The Commission adopts the following rules as reflected on the attached final rule document:

68 IAC 2-7-1; 68 IAC 2-7-2; 68 IAC 2-7-3; 68 IAC 2-7-5; 68 IAC 2-7-7; 68 IAC 2-7-8; 68 IAC 2-7-9; and 68 IAC 2-7-10.

Pursuant to IC 4-22-2, the Commission adopts the attached final rule document. Commission staff will forward the rule to the Office of the Attorney General for approval as to legality under IC 4-22-2-

32. Upon approval by the Office of the Attorney General, the rule will be submitted to the Governor's Office for approval pursuant to IC 4-22-2-33. After the rule has been approved or deemed approved by the Governor, the rule will be submitted to the *Indiana Register* for filing in accordance with IC 4-22-2-35.

SECTION 4: EFFECTIVE DATE

This resolution is effective immediately.
