

**ORDER 2014-184**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**RENEWING THE CASINO OWNER'S LICENSE**  
**OF BLUE CHIP CASINO, LLC**

The Indiana Gaming Commission ("Commission") adopts the following order pursuant to authority granted it under IC 4-33. In accordance with and subject to Indiana Code 4-33 and Title 68 of the Indiana Administrative Code, the Commission issued a Casino Owner's License to Blue Chip Casino, Inc., effective August 19, 1997. By Resolution 1999-36, dated November 8, 1999, the Commission approved the request of Blue Chip Casino, Inc. to form a limited liability company to be known as Blue Chip Casino, LLC ("Blue Chip") and transfer the license to Blue Chip. The Commission has renewed the license annually since inception, most recently on September 12, 2013, which renewed the license through August 17, 2014.

On June 10, 2014, Blue Chip requested renewal of its owner's license and submitted payment of the annual renewal fee in the amount of five thousand dollars (\$5,000). On August 14, 2014, pursuant to a delegation of authority granted by the Commission in Resolution 2003-13, the Executive Director extended the license through a date when the Commission could consider Blue Chip's request.

On September 12, 2013, by Order 2013-169, the Commission approved a written power of attorney identifying Maunty Collins as trustee-in-waiting for Blue Chip. Order 2013-169 stated that it would expire "upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Blue Chip's casino owner's license; or (2) modifies or withdraws the approval" of Mr. Collins. On June 24, 2014, Blue Chip indicated in writing that it desires to continue to have Mr. Collins as trustee-in-waiting.

**COMMISSION ACTION**

Pursuant to Indiana Code section 4-33-6-12, the Commission finds that Blue Chip has substantially complied with the directives of Indiana Code 4-33 and Title 68 of the Indiana Administrative Code and is suitable to hold a Casino Owner's License. The Commission **GRANTS** renewal of Blue Chip's Casino Owner's License for a period of one year subject to Blue Chip maintaining its casino gambling operation, riverboat, hotel, pavilion, and resort amenities in substantial compliance with all properly applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders and/or other directives relating to the casino owner's license, or to the lawful operation or conduct of casino gaming in Indiana. The renewal of the Casino Owner's License shall be valid for a period of one year from August 18, 2014 through August 17, 2015.

Furthermore, the Commission **GRANTS** renewal of its approval of the written power of attorney identifying Maunty Collins as trustee-in-waiting for Blue Chip. The renewal of the Commission's approval expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Blue Chip's casino owner's license; or (2) modifies or withdraws the renewal of its approval as granted herein.

According to IC 4-21.5-3, this order is effective fifteen (15) days after the order is served.
