

**ORDER 2014-236**  
**RENEWING THE CASINO OWNER'S LICENSE**  
**OF CAESARS RIVERBOAT CASINO, LLC**  
**d/b/a HORSESHOE SOUTHERN INDIANA**

The Indiana Gaming Commission ("Commission") adopts the following order pursuant to authority granted it under IC 4-33. In accordance with and subject to IC 4-33 and Title 68 of the Indiana Administrative Code, the Commission issued a Casino Owner's License to Caesars Riverboat Casino, LLC d/b/a Horseshoe Southern Indiana ("Horseshoe South"), effective November 20, 1998. Pursuant to IC 4-33-6-12, the license has been renewed annually since inception. The most recent renewal, granted on November 21, 2013, renewed the Casino Owner's license through November 15, 2014.

On October 14, 2014, Horseshoe South requested renewal of its Casino Owner's License and submitted payment of the annual renewal fee. On November 5, 2014, pursuant to a delegation of authority granted by the Commission in Resolution 2003-13, the Executive Director extended the license through a date when the Commission could consider Horseshoe South's request.

On November 21, 2013, by Order 2013-209, the Commission renewed a written power of attorney identifying Charles Atwood as trustee-in-waiting for Horseshoe South. Order 2013-209 stated that the power of attorney would expire "upon the effectiveness of a subsequent Commission order that either (1) addresses the renewal of Horseshoe South's Casino Owner's License; or (2) modifies or withdraws the approval" of Mr. Atwood. On October 14, 2014, Horseshoe South indicated in writing that it desires to continue to have Mr. Atwood as trustee-in-waiting.

**COMMISSION ACTION**

Pursuant to IC 4-33-6-12, the Commission finds that Horseshoe South has substantially complied with the directives of IC 4-33 and Title 68 of the Indiana Administrative Code and is suitable to hold a Casino Owner's License. The Commission **GRANTS** renewal of Horseshoe South's Casino Owner's License for a period of one year subject to Horseshoe South maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all properly applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders and/or other directives relating to the Casino Owner's License, or to the lawful operation or conduct of gaming in Indiana. The renewal of the Casino Owner's License is valid for a period of one year from November 16, 2014 through November 15, 2015.


Furthermore, the Commission **GRANTS** renewal of its approval of the written power of attorney identifying Charles Atwood as trustee-in-waiting for Horseshoe South. The renewal of the Commission's approval expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Horseshoe South's Casino Owner's License; or (2) modifies or withdraws the renewal of its approval as granted herein.

According to IC 4-21.5-3, this order is effective fifteen (15) days after the order is served.
