**ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE RENEWAL OF SUPPLIER'S LICENSES**

In accordance with and subject to Indiana Code 4-33, Indiana Code 4-35, and 68 IAC 2-2 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") has previously issued permanent supplier's licenses to: (1) Bally Gaming, Inc.; (2) Data Financial, Inc.; (3) DEQ Systems Corp.; (4) Digideal Corp.; (5) Elektroncek d.d.; (6) International Game Technology; (7) Incredible Technologies, Inc.; (8) Midwest Game Supply Co.; (9) Patriot Gaming & Electronics, Inc.; (10) Southwest Surveillance Systems; (11) Technical Security Integration, Inc.; (12) TCS John Huxley Europe LTD; and (13) WMS Gaming, Inc.

A supplier's license is valid for a period of one (1) year and in accordance with IC 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500) as an annual renewal fee. Each of these licensees has requested renewal of licensure and paid the renewal fees. The Commission has determined that the above-named supplier licensees remain in substantial compliance with IC 4-33 and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** renewal of the licenses of each of the suppliers for a period of one year as specified below:

- 1) Bally Gaming, Inc.: valid March 30, 2014 to March 29, 2015
- 2) Data Financial, Inc.: valid March 4, 2014 to March 3, 2015
- 3) DEQ Systems, Corp.: valid March 19, 2014 to March 18, 2015
- 4) Digideal, Corp.: valid March 17, 2014 to March 16, 2015
- 5) Elektroncek d.d.: valid March 19, 2014 to March 18, 2015
- 6) International Game Technology: valid January 26, 2014 to January 25, 2015
- 7) Incredible Technologies, Inc.: valid March 4, 2014 to March 3, 2015
- 8) Midwest Game Supply Co.: valid March 27, 2014 to March 26, 2015
- 9) Patriot Gaming & Electronics, Inc.: valid March 31, 2014 to March 30, 2015
- 10) Southwest Surveillance Systems: valid March 15, 2014 to March 14, 2015
- 11) Technical Security Integration, Inc.: valid March 17, 2014 to March 16, 2015
- 12) TCS John Huxley Europe LTD: valid March 19, 2014 to March 18, 2015
- 13) WMS Gaming, Inc.: valid March 17, 2014 to March 16, 2015

Each licensee must notify the Commission of its desire to be considered for a subsequent license renewal at least thirty (30) days before the expiration of the license.
