

**RESOLUTION 2014-57**  
**A RESOLUTION ADOPTING LSA DOCUMENT #12-659 AS A FINAL RULE**

The Indiana Gaming Commission (“Commission”) adopts the following resolution pursuant to the authority granted to it under Indiana Code (“IC”) 4-33-4 and IC 4-35-4.

The Commission has considered the following factors:

1. The Commission began promulgation of the attached LSA Rule Document #12-659 under IC 4-22. A Notice of Intent to adopt LSA Rule Document #12-659 was posted at DIN: 20121212-IR-068120659NIA on the *Indiana Register* website on December 12, 2012. The Indiana Register posted the proposed rule at 20130807-IR-068120659PRA on the *Indiana Register* website on August 7, 2013. An Administrative Rules Oversight Committee Notice was posted at DIN: 20130807-IR-068120659ARA on the *Indiana Register* website on August 8, 2013.
2. The Commission held a public hearing for this rule on September 26, 2013, at 10 a.m. in the offices of the Indiana Gaming Commission, Indianapolis, Indiana, in compliance with IC 4-22. The Commission received written comments from the Casino Association of Indiana. The public hearing was continued until October 17, 2013, at 10 a.m. in the offices of the Indiana Gaming Commission, Indianapolis, Indiana, in compliance with IC 4-22. A representative of the Casino Association of Indiana attended continued hearing and thanked the Commission for receiving and considering its written comments but offered no further comments. The fiscal impact statements have all been made available to the Commission. The Commission has also considered the transcript from the public hearing.
3. Following the adoption of the attached rule document as a final rule, the final rule will be forwarded to the Office of the Attorney General and the Governor for approval, and filed thereafter with the *Indiana Register*. The rule will be effective 30 days after it is filed with the *Indiana Register*.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION,  
THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1: SCOPE**

This resolution applies to all persons subject to the authority granted to the Commission by the General Assembly in IC 4-33-4 and IC 4-35-4.

**SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33 and IC 4-35 and 68 IAC apply to this resolution.

**SECTION 3: ADOPTION OF FINAL RULES**

The Commission adopts the following rules as reflected on the attached final rule document:

**68 IAC 1-12.5-1; 68 IAC 1-12.5-2; 68 IAC 1-12.5-3; 68 IAC 1-12.5-4; and 68 IAC 15-12-3.**

Pursuant to IC 4-22-2, the Commission adopts the attached final rule document. Commission staff will forward the rule to the Office of the Attorney General for approval as to legality under IC 4-22-2-32. Upon approval by the Office of the Attorney General, the rule will be submitted to the Governor's Office for approval pursuant to IC 4-22-2-33. After the rule has been approved or deemed approved by the Governor, the rule will be submitted to the *Indiana Register* for filing in accordance with IC 4-22-2-35.

**SECTION 4: EFFECTIVE DATE**

This resolution is effective immediately.
