

ORDER 2018-24
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued permanent supplier's licenses to: (1) Bally Gaming, Inc.; (2) Data Financial, Inc.; (3) Genesis Gaming Solutions, Inc.; (4) Halifax Security, Inc.; (5) IGT; (6) Incredible Technologies, Inc.; (7) Interblock Luxury Gaming Products, d.d.; (8) Midwest Game Supply Co.; (9) Patriot Gaming and Electronics, Inc.; (10) SUZOHAPP Gaming Solutions, Inc.; (11) TCS John Huxley, Ltd.; and (12) Zuvid, LLC.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:


- 1) Bally Gaming, Inc.: valid March 30, 2018 through March 29, 2019;
- 2) Data Financial, Inc.: valid March 4, 2018 through March 3, 2019;
- 3) Genesis Gaming Solutions, Inc.: valid March 23, 2018 through March 22, 2019;
- 4) Halifax Security, Inc.: valid February 24, 2018 through February 23, 2019;
- 5) IGT: valid January 26, 2018 through January 25, 2019;
- 6) Incredible Technologies, Inc.: valid March 4, 2018 through March 3, 2019;
- 7) Interblock Luxury Gaming Products, d.d.: valid March 19, 2018 through March 18, 2019;
- 8) Midwest Game Supply Co.: valid March 27, 2018 through March 26, 2019;
- 9) Patriot Gaming and Electronics, Inc.: valid March 31, 2018 through March 30, 2019;
- 10) SUZOHAPP Gaming Solutions Inc.: valid March 20, 2018 through March 19, 2019;
- 11) TCS John Huxley Europe, Ltd.: valid March 19, 2018 through March 18, 2019; and
- 12) Zuvid, LLC: valid February 24, 2018 through February 23, 2019.

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.


