

**ORDER 2019-217**  
**AN ORDER OF THE INDIANA GAMING COMMISSION REGARDING**  
**BELTERRA RESORT INDIANA, LLC'S REQUEST TO MOVE CERTAIN**  
**GAMING DEVICES INLAND PURSUANT TO IND. CODE § 4-33-6-24**

Ind. Code § 4-33-6-24 allows a casino owner licensee to submit a plan to the Commission to relocate the casino owner licensee's gaming operations from a docked riverboat to an inland casino.

In order to relocate inland, a casino owner licensee must satisfy the four conditions set forth in Ind. Code § 4-33-6-24(c). First, the casino must be located on property that the casino owner licensee owned or leased and used in the conduct of gaming operations on February 1, 2015. Second, the new inland casino must be located on property adjacent to the riverboat dock site. Third, the casino must comply with all building codes and safety requirements imposed by the Commission. Fourth, the Commission must approve relocation.

In addition to the above requirements, the number of gambling games to be offered at the inland casino cannot exceed the greatest number of gambling games the casino owner licensee offered at the docked riverboat casino since January 1, 2007. Ind. Code § 4-33-6-24(f).

On October 11, 2019, Belterra Resort Indiana, LLC d/b/a Belterra Casino Resort ("Beltterra") submitted its request to offer additional gambling games at its previously-approved inland gaming area. The inland location is located adjacent to the riverboat dock site. The inland location is located on property that currently is and was owned by Belterra as of February 1, 2015. The total number of gambling games will not exceed cap established via Ind. Code § 4-33-6-24(f).

**COMMISSION ACTION**

1. The Commission hereby **APPROVES** Belterra's request to relocate certain gaming operations from the docked riverboat casino inland, subject to the conditions the follow.
2. The Commission's approval of Belterra's request is conditioned upon Belterra meeting all requirements contained in Ind. Code § 4-33-6-24.
3. As an additional requirement imposed pursuant to Ind. Code 4-33-6-24(e), Belterra must receive plan approval. The details of what the plan must include and approval authority of the plan are hereby **DELEGATED** to the Executive Director.


**EFFECTIVE DATE**
