

ORDER 2022-135
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF CERTIFICATES OF AUTHORITY

In accordance with Ind. Code art. 4-38 and Title 68 of the Ind. Admin. Code, the Indiana Gaming Commission ("Commission") previously issued Certificates of Authority to: (1) Ameristar Casino East Chicago, LLC; (2) Centaur Acquisition, LLC d/b/a Horseshoe Indianapolis; (3) Indiana Gaming Company, LLC d/b/a Hollywood Casino; (4) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, Indianapolis; (5) Horseshoe Hammond, LLC; (6) Blue Chip Casino, LLC; (7) Blue Sky Casino, LLC d/b/a French Lick Resort; (8) Belterra Resort Indiana, LLC; (9) Aztar Indiana Gaming Company, LLC d/b/a Bally's Evansville; (10) Caesars Riverboat Casino, LLC d/b/a Caesars Southern Indiana; (11) Centaur Acquisition, LLC d/b/a Caesars Race and Sportsbook, Clarksville; (12) Hoosier Park, LLC d/b/a Harrah's Hoosier Park; (13) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, New Haven.

A certificate of authority is valid for a period of one year, beginning on the anniversary of the date that certificate holders commences sports wagering operations. Further, in accordance with Ind. Code § 4-38-8-1, a certificate of authority must be renewed annually along with the payment of Fifty Thousand Dollars (\$50,000.00) as an annual administrative fee. Each of these certificate holders has requested renewal and paid the required administrative fee. The Commission has determined that the above-named certificate holders remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-38, and Title 68 of the Indiana Administrative Code and are suitable to hold a certificate of authority. Prior to this meeting, pursuant to a delegation of authority granted by the Commission in Resolution 2019-257, the Executive Director extended the licenses through a date when the Commission could consider these renewal requests.


The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) Ameristar Casino East Chicago, LLC: valid September 1, 2022 through August 31, 2023;
- 2) Centaur Acquisition, LLC d/b/a Horseshoe Indianapolis: valid September 1, 2022 through August 31, 2023;
- 3) Indiana Gaming Company, LLC d/b/a Hollywood Casino: valid September 1, 2022 through August 31, 2023;
- 4) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, Indianapolis: valid September 3, 2022 through September 2, 2023;
- 5) Horseshoe Hammond, LLC: valid September 4, 2022 through September 3, 2023;
- 6) Blue Chip Casino, LLC: valid September 5, 2022 through September 4, 2023;
- 7) Blue Sky Casino, LLC d/b/a French Lick Resort: valid September 6, 2022 through September 5, 2023;
- 8) Belterra Resort Indiana, LLC: valid September 9, 2022 through September 8, 2023;
- 9) Aztar Indiana Gaming Company, LLC d/b/a Bally's Evansville: valid September 12, 2022 through September 11, 2023;
- 10) Caesars Riverboat Casino, LLC d/b/a Caesars Southern Indiana: valid September 12, 2022 through September 11, 2023;
- 11) Centaur Acquisition, LLC d/b/a Caesars Race and Sportsbook, Clarksville: valid September 12, 2022 through September 11, 2023;
- 12) Hoosier Park, LLC d/b/a Harrah's Hoosier Park: valid September 19, 2022 through September 18, 2023;
- 13) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, New Haven: valid September 19, 2022 through September 18, 2023.


Each certificate holder must notify the Commission of its desire to be considered for subsequent certificate renewal at least thirty days before the expiration of the license. According to Ind. Code ch. 4-21.5-3, this Order is effective fifteen days after it is served.
