

ORDER 2022-167
AN ORDER OF THE INDIANA GAMING COMMISSION PROSPECTIVELY RENEWING
THE CASINO OWNER'S LICENSE AND POWER OF ATTORNEY OF INDIANA GAMING
COMPANY, LLC d/b/a HOLLYWOOD CASINO LAWRENCEBURG

In accordance with Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") issued a casino owner's license to Indiana Gaming Company, LLC d/b/a Hollywood Casino Lawrenceburg ("Hollywood"), effective March 2, 2001. The Commission has renewed this license annually since inception, most recently on December 15, 2022, which renewed the license through December 9, 2023.

On October 26, 2023, Hollywood requested renewal of its casino owner's license and submitted the required annual renewal payment in the amount of \$5,000. On November 27, 2023, pursuant to a delegation of authority granted by the Commission in Resolution 2019-257, the Executive Director extended the license through a date when the Commission could consider Hollywood's request.

On December 15, 2022, by Order 2022-195, the Commission approved a renewal of the written power of attorney identifying Mr. Thomas Dingman as trustee-in-waiting for Hollywood. Order 2022-195 stated this approval would expire "upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Hollywood's casino owner's license; or (2) modifies or withdraws the approval" of Mr. Dingman. On October 26, 2023, Hollywood indicated in writing its desire to maintain Mr. Dingman as its trustee-in-waiting.

COMMISSION ACTION

Pursuant to Ind. Code § 4-33-6-12, the Commission found that Hollywood substantially complied with the requirements set forth in Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code; therefore, Hollywood is suitable to hold a casino owner's license. The Commission **GRANTS** renewal of Hollywood's casino owner's license for a period of one year subject to Hollywood maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders, and/or other directives relating to the casino owner's license or the lawful conduct or operation of gaming in Indiana. The renewal of the casino owner's license is valid for a period of one year from December 10, 2023, through December 9, 2024.


Furthermore, the Commission **APPROVES** renewal of power of attorney identifying Mr. Thomas Dingman as trustee-in-waiting for Hollywood. The renewal expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Hollywood's casino owner's license; or (2) modifies or withdraws the approval of Mr. Dingman as granted herein.


According to Ind. Code ch. 4-21.5-3, this Order is effective fifteen days after it is served.
