RESOLUTION 2022-183 ADOPTING LSA DOCUMENT #22-69 AS A FINAL RULE

The Indiana Gaming Commission ("Commission") adopts this resolution pursuant to the authority granted under Ind. Code § 4-33-4-3 and Ind. Code § 4-35-4-2.

The Commission has considered the following factors:

- 1. In order for the Commission to fulfill its responsibilities under IC 4-33-4, IC 4-35-4, and 68 IAC, measures to enhance the accountability of privately held companies must be executed.
- 2. On January 18, 2022, the Commission received approval from the Office of Management and Budget to promulgate rules concerning new requirements for licensees and other persons subject to the jurisdiction of the Commission pursuant to an exception to the Regulatory Moratorium.
- 3. The Commission began promulgation of LSA Document #22-69 pursuant to Ind. Code § 4-22. The *Indiana Register* posted the LSA Document #22-69 Notice of Intent to Adopt at DIN: 20220309-IR-0682200690NIA on March 9, 2022, and the Proposed Rule at DIN: 20220727-IR-068220069PRA on July 27, 2022.
- 4. The Commission held a public hearing on August 23, 2022 at 10:00AM in compliance with Ind. Code § 4-22. There were no attendees other than Commission staff, and no comments were submitted at the meeting.
- 5. The Commission received public comments during the public comment period and has addressed the concerns presented during that time.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1: SCOPE

This resolution applies to all licensees and other persons subject to the jurisdiction of the commission pursuant to IC 4-33 and IC 4-35.

SECTION 2: DEFINITIONS

The definitions set forth in Ind. Code § 4-33, Ind. Code § 4-35, and Title 68 of the Indiana Administrative Code apply to this resolution.

SECTION 3: ADOPTION OF THE FINAL RULE

The Commission adopts the following rules as reflected on the attached Final Rule document:

Adds 68 IAC 3.1.

Pursuant to Ind. Code § 4-22-2, the Commission approves the attached LSA document #22-69 Final Rule. Commission staff will forward the rule to the Office of the Attorney General for approval as to legality under Ind. Code § 4-22-2-32. Upon approval by the Office of the Attorney General, the rule will be submitted to the Governor's Office for approval pursuant to Ind. Code § 4-22-2-33. After the rule has been approved by the Governor, the rule will be submitted to the *Indiana Register* for filing in accordance with Ind. Code § 4-22-2-35. The Commission further approves and adopts any stylistic, grammatical, typographical, or other non-substantive changes that the Commission staff or the Legislative Services Agency may make to the rule document before it is printed as a final rule in the *Indiana Register*.

SECTION 4: EFFECTIVE DATE

This resolution is effective immediately.
