

## APPLICATION FOR INITIAL LICENSURE OR RENEWAL OF LICENSURE AS A BOXING AND BARE- KNUCKLE PROMOTER

- INSTRUCTIONS: 1. Any individual or company who wishes to promote a professional or a pro-am boxing event or bare-knuckle must first obtain a license promoter from the Commission.
  - 2. a promoter license is an annual license that expires on September 30 of each year, regardless of the date of issuance.
  - 3. The following information is required to be submitted to an initial boxing promoter license to be issued:
    - (A) Completed Application for Initial Licensure or Renewal of Licensure as a Boxing and Bare-Knuckle Promoter.
    - (B) Clear photocopies of current government issued photographic identification cards (i.e. driver's license, passport) of the principal owner, all substantial owners, and all key persons of the company.
    - (C) A digital photograph of the principal owner, all substantial owners, and all key persons of the company, which shows head and shoulders only, without a hat, and in a natural pose. Please email the digital photograph(s) to iac@igc.in.gov and include the name in the subject line.
    - (D) The following Exhibits:
      - Exhibit 1: A list of any other names under which the individual or company has operated in the promotion of boxing events or mixed martial arts events in Indiana or any other state, country, or tribal nation.
      - Exhibit 2: A list of any combat sports promoter licenses held, whether active or inactive, in any other state, country, or tribal nation.
      - Exhibit 3: A surety bond in an amount of no less than ten thousand dollars (\$10,000) on the form prescribed by the Commission.
      - Exhibit 4: Proof of good standing in the applicant's state of incorporation.
      - Exhibit 5(a): A current corporate structure organizational chart.
      - Exhibit 5(b): A current personnel organizational chart.
      - Exhibit 6: A criminal history background check conducted by the Federal Bureau of Investigation of the principal owner, all substantial owners, and all key persons of the company. (The guidelines and necessary paperwork for this process can be found on the Commission's website. Applicants are advised that pursuant to IC 4-33-4-18, all fingerprints provided by applicants will be forwarded to the Federal Bureau of Investigation for a complete national criminal history check. Applicants will have the opportunity to disprove the information contained in the criminal history return. Corrections or updates to the return of criminal history may be pursued by following the procedures contained in Title 28, C.F.R., § 16.34.)
  - 4. The license fee for this application is \$300.00. Checks and money orders should be made payable to the Indiana Gaming Commission. Please mail, along with the necessary information above, to:

5. The applicant is under a continuing duty to maintain suitability to be licensed as a boxing promoter and must update the Commission of any changes to company information including arrests, charges, or indictments. Failure to report any arrest, detainment, charge, indictment, or conviction that has not been expunged or sealed by a court whether a misdemeanor or felony, is cause for denial of licensure, revocation of the license, or disciplinary action against the applicant.
