

**ORDER 2025-101**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**CONCERNING RENEWAL OF SUPPLIER'S LICENSES**

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission (“Commission”) previously issued supplier’s licenses to: (1) Gaming Partners International USA, Inc.; (2) Aces Up Gaming Inc.; (3) EDF Compliance LLC; (4) Everi Games, Inc.; (5) GLP Capital LP.; (6) Score Media and Gaming, Inc. d/b/a theScore; (7) NYX Digital Gaming (USA), LLC; (8) Galaxy Gaming, Inc.; and (9) Global Surveillance Associates, Inc.

A supplier’s license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier’s license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, Ind. Code art. 4-38, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier’s license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) Gaming Partners International USA, Inc.: valid August 19, 2025 through August 18, 2026;
- 2) Aces Up Gaming Inc.: valid September 15, 2025 through September 14, 2026
- 3) EDF Compliance LLC: valid September 15, 2025 through September 14, 2026;
- 4) Everi Games, Inc: valid September 15, 2025 through September 14, 2026;
- 5) GLP Capital LP.: valid September 19, 2025 through September 18, 2026;
- 6) Score Media and Gaming, Inc. d/b/a theScore September 26, 2025 through September 25, 2026;
- 7) NYX Digital Gaming (USA), LLC: valid September 28, 2025 through September 27, 2026;
- 8) Galaxy Gaming, Inc.: valid September 29, 2025 through September 28, 2026;
- 9) Global Surveillance Associates, Inc.: valid October 1, 2025 through September 30, 2026;

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.
