ORDER UNDER RESOLUTION 2025-150

The Indiana Gaming Commission (“Commission”) hereby issues an order pursuant to resolution 2025-150, regarding the readoption of administrative rules under Ind. Code ch. 4-22-2.6. This action is being initiated to readopt administrative rules that are set to expire January 1, 2026.

Parties

1. The Commission is the Indiana administrative agency with its principal offices in Marion County, Indiana, with powers and duties to administer, regulate, and enforce the system of riverboat gambling in the State. Ind. Code § 4-33-4-1.

Law

2. The Commission is a state agency that was created under Ind. Code § 4-33-4-1.

3. The Commission has rulemaking authority and may readopt a rule in anticipation of a rule's expiration without changes in conformity with certain procedures. Ind. Code § 4-33-4-21; Ind. Code ch 4-22-2.6.

4. A readopted rule takes effect at least thirty (30) days after the date and time that the rule was accepted for filing. Inc. Code § 4-22-2.6-8.

5. The Commission has temporarily delegated the power and authority to readopt administrative rules to the Executive Director. The Executive Director must report any action taken at the next regularly occurring meeting. Ind. Gaming Comm'n Res. 2025-150.

Facts

6. Many of the rules to be readopted have been in effect since 1996 or earlier. Rules found in Ind. Admin. Code § 21 and Ind. Admin. Code § 27 have been in effect since 2021. All these rules have been readopted when required. Most recently the rules were readopted or adopted in 2019 and 2021 and are set to expire January 1, 2026. As a result, the readoption of those rules must be before December 1, 2025. The next scheduled Commission meeting is not until December 18, 2025.

7. The rules to be readopted are as follows:

68 IAC 1	General Provisions
68 IAC 2	Licenses and Approval of Associated Equipment
68 IAC 7	Denial and Exclusion Hearings
68 IAC 8-2	Medical Services; Emergency Response
68 IAC 13	Seizure Forfeiture and Disciplinary Hearings
68 IAC 17-2	Live Gaming Device Movements
68 IAC 21	Charity Gaming
68 AC 27	Sports Wagering

8. The Commission filed a notice of the proposed readoption including a thirty (30) day public comment period pursuant to Ind. Code § 4-22-2.6-5. No objections or request to separate any part of the referenced rules from the abbreviated readoption process have been received. The Commission has considered and responded to all comments received.

9. An order under Commission Resolution 2025-150 is necessary to comply with the requirements of Ind. Code ch. 4-22-2.6 and to prevent the expiration of any rules set to expire January 1, 2026.


Findings and Order
