**Re:** Housing for Youth Aging Out of Foster Care

IHCDA, in conjunction with the Division of Child Services (DCS), is pleased to announce a new pilot program authorized by the General Assembly during the 2023 legislative session. IHCDA has \$7,500,000 (\$5,000,000 in new state funding + a \$2,500,000 IHCDA matching contribution from the Development Fund) available to be used to develop housing for youth aging out of foster care (ages 18-23) in conjunction with supportive services.

The program concept is that a 501(c)(3) or 501(c)(4) non-profit developer will develop rental units and partner with a qualified service provider(s) to assist the tenants with life skills, budgeting, mental health counseling, receipt of a GED, job coaching, etc.

A Request for Proposals (RFP) will be issued in December 2023 with responses due within 60 days of issuance of the RFP. The selection committee reviewing the RFP responses will consist of staff from IHCDA and DCS. It is anticipated that three respondents will be selected no later than March 31, 2024. Each of the three selected respondents will be eligible to receive up to \$2,500,000 in the form of a grant to develop rental units serving the target population. Selected respondents must provide a 10% match of non-IHCDA funds. The RFP response must identify the non-profit developer as well as all service provider(s) and the location of the proposed development.

A public meeting will be held on November 14, 2023 at IHCDA's office located at 30 South Meridian Street, Suite 900, Indianapolis, IN 46204 from 10:00 a.m. to 12:00 p.m. Eastern Time. Interested parties are strongly encouraged, but not required to attend. The purpose of the meeting is to provide information about the program, answer questions, and give attendees the opportunity to connect non-profit developers with service providers.
