

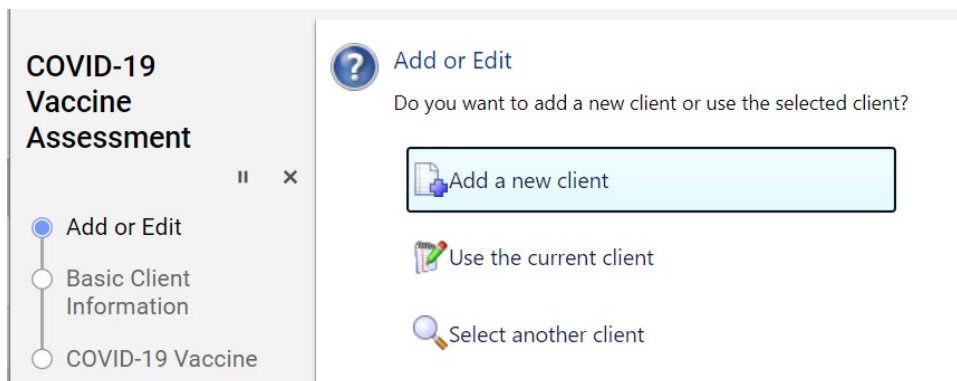
COVID-19 Vaccine Assessment

March 11, 2021

ClientTrack has created a new assessment for communities to collect data related to COVID-19 vaccinations. Communities can now enter data related to client vaccination status, dates of vaccinations, manufacturer of vaccine, and information on why some clients may opt out of receiving the vaccine.



This option launches a workflow allowing the user to search for an existing client record or add a new client record that may not already be in the system.



After selecting **Add a new client**, the system will check for potential duplicate client records. If a potential duplicate is found, you can select that client from the list displayed. If no duplicate is found, click next in the bottom right of the screen.

After saving the basic demographic data, the COVID-19 Vaccine Assessment will launch. You'll find basic information regarding the available vaccines with dosage guidelines. The assessment relies on field dependencies to guide the user during data collection.

The assessment can be linked to a Master Assessment or it can be left unlinked. The name of the assessor will default to the current user's name and can be updated as needed. There is also a comment box to enter information relevant to the assessment and client.

*The Johnson & Johnson vaccine is one-dose and the option to collect data on a second dose will not appear.

*The Moderna vaccine is a two-dose vaccine and it's recommended to be administered 21 days apart.

*The Pfizer-BioNTech vaccine is a two-dose vaccine and it's recommended to be administered 28 days apart.

If the client has NOT received the first dose of the COVID-19 Vaccination, there is an option to select the primary concern the client provides as their reason for not receiving the vaccine.

If the client has received the first dose of the COVID-19 vaccination, you'll then be required to enter the Date of Vaccination and Manufacturer information. Additional information regarding the location of the vaccination and the administration site can also be entered, but is not required.

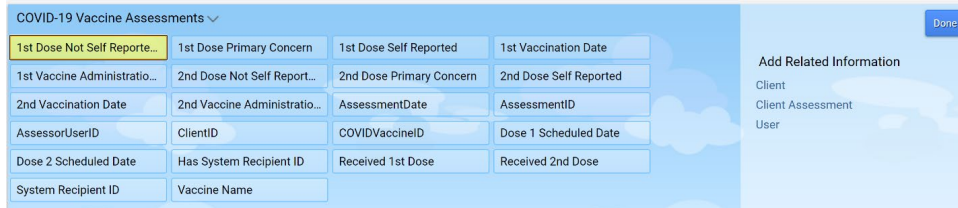
