



COVID-19 Emergency Relief Program

Using Delegated Authority, IHCDA allocated \$400,000 from their Emergency Housing Disaster Relief Fund to create the COVID-19 Emergency Relief program. Working closely with the Indiana Balance of State Continuum of Care, one organization in each of their 16 regions was eligible to receive a \$25,000 grant to support individuals experiencing homelessness who might be affected by the outbreak. Provided below is a chart which outlines the funding that was awarded.
