## INDIANA EMERGENCY RENTAL ASSISTANCE (IERA2) PROGRAM

The Indiana Emergency Rental Assistance (IERA2) program, which started taking applications in March 2023, supports renter households that have experienced financial hardship during the pandemic by offering rental and utility assistance.

### **IERA2 can provide the following benefits to eligible households:**

- One rental assistance payment that includes arrears (past due rent) and three months of forward (future) rent.
- The total amount of the first payment will depend on how many months of past due rent your household owes. If your household is current on rent, the first payment will consist of three months of forward-facing rent.
- IERA2 offers one payment to each eligible household. Additional payments may be available to households that participate in family development counseling and have additional months of assistance remaining.
- Subsequent payments may be issued that include arrears and forward-facing rent if your household participates in INCAA family development counseling and improves your household's score to "self-sufficient" or better in any one of twelve focus areas.
- No household may receive more than 18 months of assistance from any combination of ERA programs. This includes programs in Elkhart, Hamilton, Marion, Lake, St. Joseph Counties, and the City of Fort Wayne.

### **A renter household should know:**

- Up to 18 months of rent and utility assistance may be provided to your household. This includes past due rent, future rent, and reasonable late fees.
- IERA2 will pay the lesser of the rent amount stated in the lease or the published IERA2 rental limit.

# INFORMATION FOR RENTERS

## INDIANA EMERGENCY RENTAL ASSISTANCE (IERA2) PROGRAM

- If you already receive federal rental assistance (e.g., you have a Housing Choice Voucher, live in a Project Based Rental Assistance unit, live in Public Housing, etc.) IERA2 can assist with your household's portion (the tenant's portion) of the rent.
- Payments for eligible households will be made to participating landlords.
- If your landlord is not a participating landlord, your household could still receive a benefit.
- Your household is responsible for paying any rent, late fees, or additional expenses not covered by IERA2.
- A monthly stipend corresponding to the months of rental assistance will be paid for requested utilities and home energy costs. The chart below specifies the stipend amount for each utility.

- Utility and/ or home energy assistance will be paid directly to the utility provider. Utility providers must participate in IERA2 for the utility benefit to be paid. Utilities will only be paid with the first IERA2 payment.
- Your household is responsible for any unpaid utility or home energy obligations including disconnect and reconnect fees, deposits, or collection costs.
- Utility and/or home energy assistance may not be provided for costs included in the lease.
- A benefit letter from WIC, TANF, SNAP, HIP, SSI, LIHEAP or proof from your Public Housing Authority that you receive a Housing Choice Voucher or live in a Public Housing Unit may speed up the review of your application.
- Hamilton and Marion Counties administrated their own ERA programs. If you live in Hamilton County, please contact your local Township Trustee. If you live in Marion County, IndyRent is now closed. ### To participate in the program, you should:

- Call 2-1-1 Monday-Friday from 8:00A.M.- 6:00P.M. for help creating your profile and completing the question-and-answer portion of the application.
- Call 2-1-1 Monday-Friday from 8:00A.M.- 6:00P.M. for help identifying the INCAA provider that can assist with creating your profile, the question-and-answer portion of the application, and the document collection form.
