RESOLUTION OF THE INDIANA MOTORSPORTS COMMISSION

SUPPLEMENTING THE AREA IN MARION COUNTY, INDIANA DESIGNATED AS A MOTORSPORTS INVESTMENT DISTRICT AND RELATED MATTERS

RESOLUTION NO. G2-2017

WHEREAS, the Indianapolis Motor Speedway and its ancillary facilities (collectively, the "<u>Motor Speedway</u>") are presently owned and operated by the Indianapolis Motor Speedway, LLC (the "<u>IMS</u>"); and

WHEREAS, at the request of and based upon certain information presented by the IMS, the Indiana Motorsports Commission (the "<u>Commission</u>") at a public hearing, the Commission found and determined (the "<u>Initial Findings</u>"), pursuant to I.C. 5-1-17.5 (the "Act", as amended), in its Resolution No. G5-2013, adopted on December 10, 2013 (the "<u>Initial Resolution</u>"), the following:

- A. The geographic area described in Exhibit B to the Initial Resolution (the "*Initial District Area*") constituted a "motorsports investment district" under the Act; and
- B. The improvements to be constructed, acquired, leased, and financed pursuant to the Act as proposed by IMS to the Commission, as described and detailed in Exhibit A to the Initial Resolution, including any reports and studies incorporated therein by reference ("Improvements" or "Improvement Plan") would: (i) have a positive effect on the activities of the Motor Speedway; (ii) be of a benefit to the public health and welfare; (iii) be of public utility and benefit; and (iv) protect or increase state and local tax bases and tax revenues; and
- C. The Initial District Area was created by and pursuant to the Act and the Initial Resolution; and
- D. Such undertakings were appropriate and necessary to carry out the public purposes of encouraging and fostering economic development in central Indiana, and maintaining a world-class motorsports facility in the Town of Speedway; and

WHEREAS, at the request of and based upon certain information presented to the Commission by the IMS at a public hearing, the Commission found and determined in its Resolution No. G2-2015, adopted on April 16, 2015, that the Initial District Area be supplemented by certain, additional parcels, which was then collectively referred to as the Enlarged District; and

WHEREAS, the IMS has requested that the Commission supplement the Enlarged District to include the geographic area described in the attached Exhibit A (the "<u>Additional District Area</u>"); and

WHEREAS, IMS has presented information to the Commission that such Additional District Area which it proposes be included within the Enlarged District includes only property

on which activities related to the Motor Speedway (which is a qualified motorsports facility) occur or other public property specified by the Commission in its Resolutions; and

WHEREAS, the Commission has caused the Additional District Area and the findings set forth in this Resolution to be duly reviewed and considered (including an opportunity for public comment at a hearing noticed and held as provided in I.C. 5-1-17.5-24); and

WHEREAS, by this Resolution, the Commission desires to establish the Additional District Area as part of the Enlarged District (as defined in the Commission's Resolutions G4-2013 and G2-2015, collectively, "the Commission's Resolutions"), and as part of the "motorsports investment district" under the Act and in furtherance of the purposes and intents of the Commission's Resolutions, and to take all further supporting actions required by the Act.

NOW, THEREFORE, BE IT RESOLVED, by the Commission, as follows:

- 1. The Commission's Resolutions are hereby ratified and confirmed, and the herein contained recitals are hereby adopted.
- 2. The Commission hereby remakes, ratifies, and confirms the Findings for purposes of establishing the Additional District Area to be part of the Enlarged District, which as so supplemented consists of the following properties:
 - (a) The geographic area that is included within the boundaries of the Motor Speedway (in its character as a qualified motorsports facility);
 - (b) The geographic area that is part of any adjacent property that is: (A) related to the operation of the Motor Speedway (as a qualified motorsports facility); and (B) owned by the owner of the Motor Speedway (as a qualified motorsports facility) or a subsidiary or affiliate thereof;
 - (c) The geographic area that is part of a property on which activities related to the Motor Speedway (as a qualified motorsports facility) occurs; and
 - (d) The geographic area that is part of other public property that has been specified by the Commission;

With each of the foregoing determined by reference to the maps and relationships delineated in the attached Exhibit A, and the Commission's Resolutions.

- 3. The Improvement Plan, as supplemented by this Resolution, is hereby in all respects approved, ratified, and confirmed as necessary to establish the Additional District Area as part of the Enlarged District, and the Public Finance Director of the State (the "Public Finance Director") is hereby directed to file a certified copy of such with the minutes of this hearing and meeting.
- 4. This Resolution, together with reference to the Commission's Resolutions (and their supporting data), shall be submitted to the State Budget Agency, for its review, consideration, and approval, as and in a manner consistent with the Act.

- 5. The Public Finance Director shall notify the Indiana Department of Revenue of the adoption of this Resolution, together with reference to the Commission's Resolutions (and their supporting data), as and in a manner consistent with the Act.
- 6. This Resolution and the Enlarged District shall expire as provided by the Act and the Commission's Resolutions.
- 7. This Resolution (including the geographic area related to the Motor Speedway established as a "motorsports investment district" under the Act) may be further amended and supplemented by the Commission to the extent permitted by the Act.
- 8. The provisions of this Resolution shall be subject in all respects to the Act and any amendments thereto. The provisions of this Resolution shall be supplemental to the Commission's Resolutions and shall not have the force or effect of replacing or repealing the Commission's Resolutions (including the date as of which such Commission's Resolutions became effective).
 - 9. This Resolution shall be in full force and effect as of Jonuary 1, 2016.



QMID District Boundary


Additional District Area and Initial District Area
