BEAD Pre-Qualification Guidance Document
(Version 2.0)

The Indiana Broadband Office (IBO) has had an exciting August. The next stage of the Broadband Equity, Access, and Deployment (BEAD) grant program began. Pre-Qualification for the Subgrantee Selection Process began August 26, 2024. Click here to register.

Prospective applicants interested in participating in the BEAD Subgrantee Selection Process have until September 27, 2024 to submit their pre-qualification materials. Please note that, as described in Indiana's Initial Proposal Volume II, participating in the pre-qualification process **does not** bind any internet service provider to submit a project area proposal. You can find the pre-qualification guidance here and if you missed the webinars, they are posted here.

**DE Competitive Grant Program** 

The NTIA recently announced the Notice of Funding Opportunity for the first allocation of the \$1.25 billion Digital Equity Competitive Grant program. Applicants will apply directly to the NTIA to fund digital equity activities that complement Indiana's Digital Equity Capacity grant activities.

The <u>application portal</u> through NTIA opened August 14, 2024. Applications are due on September 23, 2024. The NTIA is hosting a series of webinars each Wednesday and Thursday to assist applicants. A link to all webinars can be found <u>here</u>. NTIA has also provided a series of forms needed to complete the application that can be downloaded <u>here</u>.



### **Next Level Connections (NLC) and Indiana Connectivity Program (ICP)**



The current round of bidding on the Indiana Connectivity Program (ICP) will end on September 1, 2024. We will be evaluating newly submitted addresses for eligibility on the next round launching in October. Next Level Connections (NLC) continues finalize our agreements with awarded providers, and we will continue to work with both round 3 and round 4 projects as they continue towards completion.

#### Where is the IBO?

On August 27, 2024, the Digital Equity team traveled to South Bend's Technology Resource Center to participate in a round table discussion with members of the city's Connectivity Coalition. We shared information about the IBO's programs and learned about innovative community resources like South Bend's city-operated open Wi-Fi network.
