

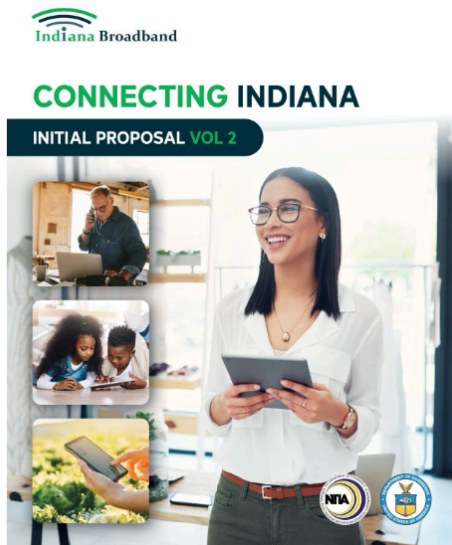

BEAD Volume 2 Approval

The Indiana Broadband Office (IBO) is excited to share that National Telecommunications and Information Administration (NTIA) announced the approval of Indiana's Broadband Equity, Access, and Deployment (BEAD) Initial Proposal Volume II.

This now means Indiana's entire Initial Proposal has been approved.

BEAD Pre-Qualification Guidance Document

The IBO has posted the Broadband Equity, Access, and Deployment (BEAD) Program pre-qualification guidance document [on our website](#). This is the first step in the subgrantee selection process. Please note that pre-qualification has **NOT** begun yet, this guidance has just been posted so all prospective applicants can be prepared.



Digital Equity Competitive Grant



The NTIA recently announced the Notice of Funding Opportunity (NOFO) for the first allocation of the \$1.25 billion Digital Equity Competitive Grant program. Applicants will apply directly to the NTIA to fund digital equity activities that complement Indiana's Digital Equity Capacity grant activities.

The application portal will open in the NTIA Grants Portal on **August 14, 2024** [here](#).

Applications are due on **September 23, 2024**. **The NTIA is hosting a series of webinars each Wednesday and Thursday to assist applicants.** A link to all webinars can be found [here](#). 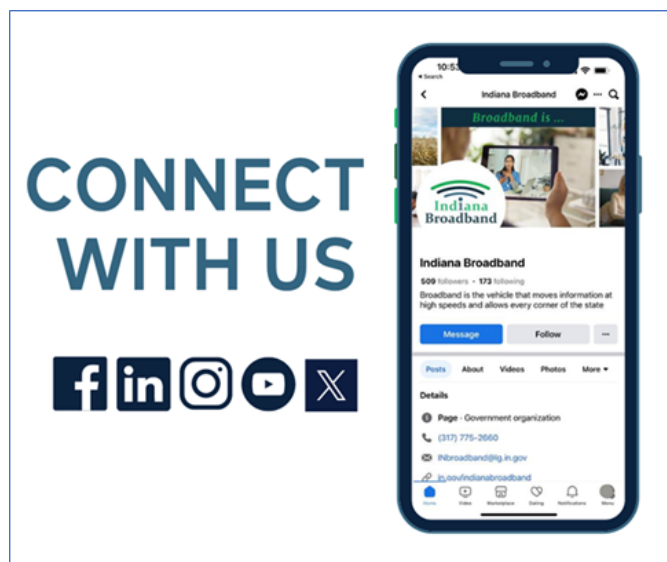
