IBO March Newsletter

The Indiana Broadband Office (IBO) hopes you had a great March. Our Digital Equity team is so excited to announce that last Friday March 29th, the National Telecommunications and Information Administration (NTIA) began making the \$1.44 billion Digital Equity Capacity Grant Program available to each state and territory. This means the IBO will apply for the Capacity Grant Program within the next 60 days and then begin to implement Indiana's Digital Equity Plan with our state's allocation of funding.

Our office was also busy starting the Challenge Phase of the Broadband Equity, Access, and Deployment (BEAD) program. The deadline for the Challenge Phase has been extended until April 17th, so there are iust over two more weeks to submit challenges.

Challenge Process Ends April 17th

The Indiana BEAD Challenge Phase ends April 17th. If you haven't already registered as a permissible challenger, you can do so on https://connectingindiana.com/register/bead now. Once you have been approved you will be granted credentials to the platform from which you can add additional users and submit any number of challenges.
