This is to inform you of the approval of an administrative amendment to the 2012-2015 Indianapolis TIP. The MPO concluded that the amendment is air quality exempt, per 40 CFR 93.126 & 127, and there is no need to update the conformity analysis or issue a new conformity finding. The Air Quality Consultation Group has been provided a copy of this amendment for informational purposes. The amendment is listed below:

- City of Indianapolis - DES # 1297293 - Monument Circle, pedestrian enhancement, related to previous study of circulation in Monument Circle (des. #0900281). Add PE phase to 2012-2015 IRTIP with a total cost of \$555,750 (\$444,600 Federal TCSP and \$111,150 local match). PE in FY 2013.
