The Indiana Department of Transportation (INDOT), with funding from the Federal Highway Administration (FHWA), proposes to proceed with the State Road (SR) 26 Road Pavement Rehabilitation Project, Des. No. 1400249.

This letter is part of the Section 106 review process for this project. Section 106 of the National Historic Preservation Act requires federal agencies to take into account the effects of their undertakings on historic and archaeological properties. We are requesting comments from you regarding the possible effects of this project. Please use the above Des. Number and project description in your reply and your comments will be incorporated into the formal environmental study.

Under Des. No. 1601105, a Section 106 early coordination letter was distributed to consulting parties on September 25, 2019 encompassing five (5) contractually bound projects: 1) Des. No. 1400249; 2) Des. No. 1601105; 3) Des. No. 1700114; 4) Des. No. 1600867; and 5) Des. No. 1800130. Since the distribution of the September 25, 2019 letter, the lead Des. No. was changed from Des. No. 1601105 to Des. No. 1400249. Therefore, Des. No. 1400249 will serve as the lead Des. No. for all current and future documents. On October 6, 2020, a historic property report (HPR) was distributed to consulting parties for review and comment.

The proposed undertaking is located on SR 26 from the east junction with US 41 to 0.16 mile east of North County Line Road West in Warren and Tippecanoe counties, Indiana. It is within Pine, Adams, and Medina townships, Warren Co. and Shelby Township, Tippecanoe Co., and Pine Village, Chatterton, and Otterbein USGS Topographic Quadrangles, in Sections 3, 4, 7, 8, 9, 10, 11, and 12 of Township 23 North, Range 8 West; Sections 7, 8, 9, 10, 11, 12, of Township 23 North, Range 7 West; and Sections 7, 8, 9, 10, 15, 16, 17, 18 of Township 23 North, Range 6 West.

The need of this corridor project is due to the deterioration of the roadway--including deficient small structures--and to improve pedestrian facilities within the Town of Pine Village. The purpose of this project is to extend the life of the roadway, improving motorist safety, and provide pedestrian facilities within the Town of Pine Village.

Des. No. 1400249 is located from the east junction of SR 26 with US 41 to the northern junction with SR 55 in Warren County, Indiana. Des. No. 1400249 involves the reconstruction of the roadway, including the addition of shoulders where necessary, a small structure replacement (Culvert No. 026-086-14.19) under Des. No. 1600867, and drainage improvements.

Des. No. 1601105 is located along SR 26 from the northern junction with SR 55 to 0.33 mile east of the southern junction with SR 55 in the Town of Pine Village, Warren County, Indiana. The project involves the reconstruction of the roadway within the project limits and will include the installation of improved pedestrian facilities and curb ramps as necessary. Additionally, the parking within the town limits will be reconfigured and an improved storm sewer system will be installed.



Des. No. 1700114 is located from 0.33 mile east of the southern junction with SR 55 to 0.16 mile east of North County Line Road West in both Warren and Tippecanoe counties, Indiana. Des. No. 1700114 involves the reconstruction of the roadway, including the addition of shoulders where necessary, a small structure replacement (Culvert No. 026-079-24.58) under Des. No. 1800130, and drainage improvements.

No work is anticipated on any of the three bridges located along the project corridor; paving exceptions for all three structures are noted on the project plans. While one of the bridges (Bridge No. 026-86-01572 A/ NBI No. 6620) is listed as eligible in the INDOT-sponsored *Historic Bridge Inventory* (Vol. 1, pg. 221), the Historic Bridge Programmatic Agreement will not be followed due to the project exception. It is anticipated that the project will require 65 acres of right-of-way acquisition. No relocations of residences or businesses are expected for this project. The letting date is Fiscal Year 2022.

Little River Consultants, LLC is under contract with INDOT to advance the environmental documentation for the referenced project. SJCA Inc. (formerly Green 3, LLC) has been subcontracted to complete the Section 106 documentation for the project.

In accordance with 36 CFR 800.2 (c), you were invited to become a consulting party as part of the Section 106 process, or you are hereby invited to become a consulting party as part of the Section 106 process. Entities that have previously accepted consulting party status--as well as additional entities that are currently being invited to become consulting parties--are identified in the attached list.

The Section 106 process involves efforts to identify historic properties potentially affected by the undertaking, to assess the undertaking's effects, and seek ways to avoid, minimize, or mitigate any adverse effects on historic properties. The Area of Potential Effects (APE) is the area in which the proposed project may cause alterations in the character or use of historic resources. The APE contains one resource listed or previously determined eligible for inclusion in the National Register of Historic Places (NRHP): INDOT Bridge No. 26-86-1572 (IHSSI#171-513-10008; HB-1758; NBI No. 6620).

A historian who meets the Secretary of the Interior's Professional Qualification Standards identified and evaluated aboveground resources within the APE for potential eligibility for the NRHP. As a result of the historic property identification and evaluation efforts, four above-ground resources are recommended as eligible for listing in the NRHP:

- Builta-Rhode Farm (IHSSI No. 171-513-05008), 9500 SR 55
- Knights of Pythias Building (IHSSI No. 171-513-06005), 110 E. Lafayette St.
- Pine Village Methodist Church (IHSSI No. 171-513-06007), 106 E. Church St.
- Pine Village Post Office (IHSSI No. 171-513-06004), 101 N. Jefferson St

With regard to archaeological resources, an archaeologist who meets the Secretary of the Interior's Professional Qualification Standards identified three new sites (12-Wa-299,12-Wa-300, and 12-T-1244) consisting of two isolated finds and one small lithic scatter within the project area (Jackson, March 10, 2021). Additionally, fieldwork was undertaken at the previously recorded locations of sites 12-Wa-253, which was previously recommended as being potentially eligible, and 12-Wa-259. No evidence of these two sites was found within the existing right of way. Site 12-Wa-253 was determined to be ineligible, and no additional investigation was recommended. Furthermore, there were an additional eight previously recorded sites (12-Wa-112, 12-Wa-173, 12-Wa-243, 12-Wa-246, 12-Wa-247, 12-Wa-293, and 12-Wa-298), or portions of those sites, mapped within or near the project area. No evidence of these sites (12-Wa-243, 12-Wa-246, and 12-Wa-247) was found by this investigation. The remaining five sites (12-Wa-112, 12-Wa-173, 12-Wa-221, and 12-Wa-293, and 12-Wa-293, and 12-Wa-298) appear to not extend into the project area. As a result of these efforts, none of these sites were recommended as eligible for listing in the NRHP and no further work was recommended.

On October 12, 2020 via email, the chairman of the administrative council for the Pine Village United Methodist Church asked: "Out near the road of State Road 26 there are some limestone blocks for a retaining wall that is there. Are they



planning on removing those and then making a new retaining wall, not going to do anything with it as just accepting the land for Right of Way, or another option? We are fearful without knowing what is to be done, that the ground will settle and force out the dirt therefore leading us to handle a costly fix down the road."

The INDOT Project Manager responded on October 12, saying: "As of right now, we are not planning on impacting these limestone blocks. They appear to be located just within the state's ROW. Currently, the town's storm sewer system empties into this ditch on the east side of the roadway, but in the proposed condition, it will drain to the west side of the roadway and the existing ditch will be regraded with less water coming to it."

Also on October 12, the chairman of the Pine Village United Methodist Church administrative council responded, stating that the project manager's response answered the church's biggest question. They further asked whether the church would have to wait for the completion of the INDOT project to add a sidewalk from the back of the church building towards the intersection of Church St. and SR 55.

The INDOT Project Manager responded to this that same day, stating that he would need to discuss these sidewalk plans with INDOT to make sure the funding is there to add a curb ramp for this planned sidewalk. He asked what the church's current plans were with the sidewalk so project engineers could design a curb ramp to receive it. The chairman responded again that same day, stating that the church was waiting to see where INDOT added a curb ramp so that the church could design a sidewalk to meet it. The chairman asked what the specifications were for/how far from the road a sidewalk needed to be placed. That same day, the project manager replied, stating: "Typically there is a 3'-5' buffer between the edge of the roadway and the sidewalk, but as you mentioned there is currently a lot of gravel in this area. I would recommend coordinating with someone in the Town of Pine Village to see if they have any requirements or recommendations for local roadways. If not, I would ask that you tell me your preference. Ultimately, we want to make sure that if we build it that it works with your plans and accommodates any changes you plan to make to your property/parking down the road."

On October 14, 2020, the Project Manager replied that he had just heard back from INDOT and that "the state does not plan to add a curb ramp at this location because there is not existing sidewalk to connect to. There is some concern with installing this in advance and it not connecting to your sidewalk properly while also meeting ADA requirements. They have recommended that the sidewalk and curb ramp be installed at the completion of the work on SR 26/SR 55."

On November 4, 2020, SHPO staff responded to the October 6, 2020 letter that accompanied the HPR, stating that the APE "appears to be of adequate size to encompass the geographic area in which direct and indirect effects of a project of this nature could occur." They also agreed with the conclusions of the HPR that the Builta-Rhode Farm (IHSSI No. 171-513-05008), Pine Village Methodist Church (IHSSI No. 171-513-06007), Pine Village Post Office (IHSSI No. 171-513-06004), and INDOT Bridge No. 26-86-1572 (IHSSI No. 171-513-10008) were eligible for inclusion in the NRHP. Regarding INDOT Bridge No. 26-86-1572 (IHSSI No. 171-513-10008), SHPO noted "the project plans to add paving exceptions in order to avoid impacts to the bridge."

SHPO also agreed that the house at 102 S. Main Street (IHSSI No. 171-513-06019) was not eligible for inclusion in the NRHP. However, the SHPO disagreed with the conclusions in the HPR about the Knights of Pythias Building (IHSSI No. 171-513-06005). They stated that "the Knights of Pythias Building located in Pine Village (IHSSI No. 171-513-06005) retains enough integrity warranting its eligibility for inclusion in the NRHP."

Response: Because the Knights of Pythias Building has been deemed eligible by the SHPO staff, the property owners of the Knights of Pythias building have been invited to become consulting parties.

#### AREA OF POTENTIAL EFFECTS (Pursuant to 36 CFR Section 800.4(a)(1))

The Area of Potential Effects (APE) of the project includes all properties adjacent to the project and those with a proximate viewshed of the project. See Appendix A for maps of the APE.

#### ELIGIBILITY DETERMINATIONS (Pursuant to 36 CFR 800.4(c)(2))

There are five resources eligible for listing in the National Register of Historic Places (NRHP):

**INDOT Bridge No. 26-86-1572 (Indiana Historic Sites and Structures Inventory (IHSSI) #171-513-10008; HB-1758; NBI #6620)** – is a riveted Warren pony truss bridge, constructed in 1933. It is recommended eligible for listing in the National Register of Historic Places (NRHP) under Criterion C since the bridge represents important innovations in bridge construction and retains the historic integrity necessary to convey its engineering significance.

**Builta-Rhode Farm, 9500 State Road (SR) 55 (IHSSI #171-513-05008)** – is a Craftsman-style house, built c. 1920. A barn and a Folk Victorian-style gable front house are also associated with the property. The property is recommended eligible for listing in the NRHP under Criterion C for its embodiment of significant characteristics of the Craftsman architectural style.

Knights of Pythias Building, 110 E. Lafayette Street (IHSSI #171-513-06005) – is an Italianate-style commercial structure, built c. 1900. It is recommended eligible for listing in the NRHP under Criterion A for its association with the Knights of Pythias fraternal order and under Criterion C for its embodiment of significant characteristics of the Italianate architectural style.

**Pine Village Methodist Church, 106 E. Church Street (IHSSI #171-513-06007)** – is a church, built in 1885, styled with Gothic Revival and Italianate elements and a sanctuary addition constructed in 1903. It is recommended eligible for listing in the NRHP under Criterion C for its embodiment of significant characteristics of the Gothic Revival and Italianate architectural styles.

**Pine Village Post Office, 101 N. Jefferson Street (IHSSI #171-513-06004)** – is a U.S. Post Office, built in 1969. It was constructed with elements of the Colonial Revival style dictated by the post office construction style guide. It is recommended eligible for listing in the NRHP under Criterion A due to its significance in Community Planning and Development.

#### EFFECT FINDING (Pursuant to 36 CFR 800.4(d)(1))

**INDOT Bridge No. 26-86-1572 (#171-513-10008; HB-1758; NBI #6620)** – The undertaking will have "No Adverse Effect" on the INDOT Bridge No. 26-86-1572.

**Builta-Rhode Farm (IHSSI #171-513-05008)** – The undertaking will have "No Adverse Effect" on the Builta-Rhode Farm.

Knights of Pythias Building (IHSSI #171-513-06005) – The undertaking will have "No Adverse Effect" on the Knights of Pythias Building.

**Pine Village Methodist Church (IHSSI #171-513-06007)** – The undertaking will have "No Adverse Effect" on the Pine Village Methodist Church.

**Pine Village Post Office (IHSSI #171-513-06004)** – The undertaking will have "No Adverse Effect" on the Pine Village Post Office.

The Indiana Department of Transportation (INDOT), acting on the Federal Highway Administration (FHWA)'s behalf, has determined a "No Adverse Effect" finding is appropriate for this undertaking. INDOT respectfully requests the Indiana State Historic Preservation Officer provide written concurrence with the Section 106 determination of effect.

**INDOT Bridge No. 26-86-1572 (#171-513-10008; HB-1758; NBI # 6620)** – This resource is used for transportation purposes and no Section 4(f) conversion will take place with this project; therefore no Section 4(f) evaluation must be completed for INDOT Bridge No. 26-86-1572 (#171-513-10008; HB-1758; NBI # 6620).

**Builta-Rhode Farm (IHSSI #171-513-05008)** – This undertaking will not convert property from the Builta-Rhode Farm, a Section 4(f) historic property, to a transportation use; INDOT, acting on FHWA's behalf, has determined the appropriate Section 106 finding is "No Adverse Effect"; therefore, no Section 4(f) evaluation is required for the Builta-Rhode Farm.

**Knights of Pythias Building (IHSSI #171-513-06005)** – This undertaking will not convert property from the Knights of Pythias Building, a Section 4(f) historic property, to a transportation use; INDOT, acting on FHWA's behalf, has determined the appropriate Section 106 finding is "No Adverse Effect"; therefore, no Section 4(f) evaluation is required for the Knights of Pythias Building.

**Pine Village Methodist Church (IHSSI #171-513-06007)** – This undertaking will not convert property from the Pine Village Methodist Church, a Section 4(f) historic property, to a transportation use; INDOT, acting on FHWA's behalf, has determined the appropriate Section 106 finding is "No Adverse Effect"; therefore, no Section 4(f) evaluation is required for the Pine Village Methodist Church.

**Pine Village Post Office (IHSSI #171-513-06004)** – This undertaking will not convert property from the Pine Village Post Office, a Section 4(f) historic property, to a transportation use; INDOT, acting on FHWA's behalf, has determined the appropriate Section 106 finding is "No Adverse Effect"; therefore, no Section 4(f) evaluation is required for the Pine Village Post Office.

#### FEDERAL HIGHWAY ADMINISTRATION DOCUMENTATION OF SECTION 106 FINDING OF "NO ADVERSE EFFECT" SUBMITTED TO THE STATE HISTORIC PRESERVATION OFFICER PURSUANT TO 36 CFR 800.5 (c) SR 26 Road Pavement Rehabilitation Project Warren and Tippecanoe counties, Indiana Des. No. 1400249; DHPA No. 24437

#### **1. DESCRIPTION OF THE UNDERTAKING**

The Indiana Department of Transportation (INDOT), with funding from the Federal Highway Administration (FHWA), proposes to proceed with the State Road (SR) 26 Road Pavement Rehabilitation Project, Des. No. 1400249.

The need of this corridor project is due to the deterioration of the roadway, including deficient small structures, and to improve pedestrian facilities within the Town of Pine Village. The purpose of this project is to extend the life of the roadway, improving motorist safety, and provide pedestrian facilities within the Town of Pine Village.

Des. No. 1400249 is located from the east junction with US 41 to the northern junction with SR 55 in Warren County, Indiana. Des. No. 1400249 involves the reconstruction of the roadway, including the addition of shoulders where necessary, a small structure replacement (CV 026-086-14.19) under Des. No. 1600867, and drainage improvements.

Des. No. 1601105 is located along SR 26 from the northern junction with SR 55 to 0.33 mile east of the southern junction with SR 55 in the Town of Pine Village, Warren County, Indiana. The project involves the reconstruction of the roadway within the project limits and will include the installation of improved pedestrian facilities and curb ramps as necessary. Additionally, the parking within the town limits will be reconfigured with new markings and an improved storm sewer system will be installed.

Des. No. 1700114 is located from 0.33 mile east of the southern junction with SR 55 to 0.16 mile east of North County Line Road West in both Warren and Tippecanoe counties, Indiana. Des. No. 1700114 involves the reconstruction of the roadway, including the addition of shoulders where necessary, a small structure replacement (CV 026-079-24.58) under Des. No. 1800130, and drainage improvements.

No work is anticipated on any of the three bridges located along the project corridor. Paving exceptions for all three are noted on the plans. While one of the bridges (INDOT Bridge No. 26-86-1572) is listed as eligible in the INDOT-sponsored *Historic Bridge Inventory* (Vol. 1, pg. 221), the Historic Bridge Programmatic Agreement will not be followed due to the project exception. It is anticipated that the project will require 65 acres of right-of-way acquisition. No relocations of residences or businesses are expected for this project. The letting date is fiscal year 2022.

The area of potential effects (APE), as defined in 36 CFR 800.16(d), is "the geographic area or areas within which an undertaking may directly or indirectly cause alterations in the character or use of historic properties, if any such properties exist." The APE of the project includes all properties adjacent to the project and those with a proximate viewshed of the project. Urban development limited the APE within the Town of Pine Village while the curvature of the road and tree growth limited the APE outside the town. The APE is approximately 16 miles long and is approximately 0.13 mile at its widest point.

#### 2. EFFORTS TO IDENTIFY HISTORIC PROPERTIES

The NRHP, Indiana Register of Historic Sites and Structures (State Register), and the Indiana Historic Buildings, Bridges, and Cemeteries Map (IHBBCM), showing results of the Indiana Historic Sites and Structures Inventory (IHSSI), were consulted. There are no Historic American Building Survey (HABS)/Historic American Engineering Record (HAER)/Historic American Landscapes Survey (HALS) resources identified within the vicinity of the project. The INDOT-sponsored *Indi n Historic Bridge Inventory* (HBI), *o u e : isting o Historic nd on Historic Bridges* (February 2009) by M & H Architecture, Inc. was reviewed.

On September 25, 2019, an Early Coordination Letter (ECL), under the then lead Des. No. 1601105, was distributed to consulting parties inviting them to participate in the Section 106 process. Below is the list of invited consulting parties. Those identified in bold print are participating consulting parties. SHPO was also sent a hard copy of the letter.

On September 27, 2019, the Pokagon Band of Potawatomi Indians sent a letter accepting the invitation to serve as a consulting party for the proposed project. They offered no objection to the project and made a determination that there would be "No Historic Properties in Area of Potential Effects (APE) significant to the Pokagon Band of Potawatomi Indians."

On October 15, 2019, the SHPO responded to the early coordination letter, stating that they were "not aware of any parties who should be invited to participate in the Section 106 consultation on this project, beyond those whom INDOT already has invited."

Connie Ziegler, a qualified professional (QP) historian, conducted a site visit of the project area on November 8, 2019. Karen Wood, a qualified professional historian with Green 3 (now SJCA Inc.), conducted an additional site visit on March 5, 2020. Both historians documented above-ground resources within the APE that are at least 50 years of age or that will be at least 50 years of age at the time of the project letting (expected 2022). The historians walked and drove both the project alignment and the APE, taking photographs of all resources meriting a Contributing or higher rating. Non-contributing resources or those that did not meet the age requirements were noted but not documented other than in general streetscape photographs. Please see Appendix B for photos.

A Historic Property Report (HPR) was completed for the project (Karen Wood, October 2020). The APE contains one resource listed or previously determined eligible for inclusion in the NRHP: INDOT Bridge No. 26-86-1572 (IHSSI # 171-513-10008; HB-1758; NBI 6620). This bridge was surveyed for and recommended eligible by the 2009 INDOT-sponsored *HBI*. Three resources were recommended eligible for listing in the NRHP: Builta-Rhode Farm, IHSSI #171-513-05008; Pine Village Methodist Church, IHSSI #171-513-06007; and the Pine Village Post Office, IHSSI #171-513-06004.

After the ECL was sent out, Des. No. 1400249 replaced Des. No. 1601105 as the new lead Des. No. Under Des. No. 1400249, the Report Distribution letter dated October 6, 2020 that accompanied the HPR invited the following property owners of the three recommended historic properties:

- Lon and Linda Akers, property owners of Builta-Rhode Farm, 9500 SR 55
- Trustees of Pine Village Methodist Church, property owner of Pine Village Methodist Church, 106 E. Church St.
- J. Leonard Spodek, DBA Nationwide Postal Management, property owners of Pine Village Post Office, 101 N. Jefferson St.

On October 6, 2020, the HPR was distributed to invited consulting parties. SHPO received a hard copy of this letter and report. The summary of the HPR can be found in Appendix D.

On November 4, 2020, SHPO stated that the APE "appears to be of adequate size to encompass the geographic area in which direct and indirect effects of a project of this nature could occur." They also agreed with the conclusions of the HPR that the Builta-Rhode Farm (IHSSI No. 171-513-05008), Pine Village Methodist Church (IHSSI No. 171-513-06007), Pine Village Post Office (IHSSI No. 171-513-06004), and INDOT Bridge No. 26-86-1572 (IHSSI No. 171-513-10008) were eligible for inclusion in the NRHP. Regarding INDOT Bridge No. 26-86-1572 (IHSSI No. 171-513-10008), SHPO noted "the project plans to add paving exceptions in order to avoid impacts to the bridge." They also agreed that the house at 102 S. Main Street (IHSSI No. 171-513-06019) was not eligible for inclusion in the NRHP. However, SHPO disagreed with the conclusions in the HPR regarding the Knights of Pythias Building (IHSSI No. 171-513-06005). They stated that "the Knights of Pythias Building (IHSSI No. 171-513-06005) retains enough integrity warranting its eligibility for inclusion in the NRHP."

With regard to archaeological resources, an archaeologist who meets the Secretary of the Interior's Professional Qualification Standards identified three new sites (12-Wa-299,12-Wa-300, and 12-T-1244) consisting of two isolated finds and one small lithic scatter within the project area (Jackson, March 10, 2021). Additionally, fieldwork was undertaken at the previously recorded locations of sites 12-Wa-253, which was previously recommended as being potentially eligible, and 12-Wa-259. No evidence of these two sites was found within the existing right of way. Site 12-Wa-253 was determined to be ineligible, and no additional investigation was recommended. Furthermore, there were an additional eight previously recorded sites (12-Wa-112, 12-Wa-173, 12-Wa-221, 12-Wa-246, 12-Wa-247, 12-Wa-293, and 12-Wa-298), or portions of those sites, mapped within or near the project area. No evidence of these sites (12-Wa-143, 12-Wa-246, and 12-Wa-247) was found by this investigation. The remaining five sites (12-Wa-112, 12-Wa-246, and 12-Wa-293, and 12-Wa-293, and 12-Wa-298) appear to not extend into the project area. As a result of these efforts, none of these sites were recommended as eligible for listing in the NRHP and no further work was recommended. A summary of the report can be found in Appendix D.

None of the other consulting parties provided any additional comments regarding the early coordination letter, or HPR. Please see Appendix C for Consulting Party Correspondence.

#### **3. DESCRIBE AFFECTED HISTORIC PROPERTIES**

**INDOT Bridge No. 26-86-1572 (IHSSI #171-513-10008; HB1758; NBI #6620)**, was previously determined eligible for the NRHP under Criterion C as part of the INDOT-sponsored *HBI*. It is a riveted Warren pony truss bridge, constructed in 1933. The bridge consists of two panels composing a single span of 95.8 feet with a deck

width of 23.9 feet. Connecting the beams to the main truss are metal rivets. The bridge underwent minor alterations in 2000 to fix some issues with its siding. According to the *HBI*, this bridge is eligible under Criterion C because "it represents a variation, evolution, or transition that is conveyed through important features or innovations related to bridge construction, design, or engineering, and it retains the historic integrity necessary to convey its engineering significance . . . display[ing] exceptional overall or main span length for its type, thus representing an innovative design and/or construction method . . . [And] it represents a significant phase or feature of the work of a master. It is distinguishable when compared to similar structures and retains the historic integrity necessary to convey engineering or design significance . . . exhibit[ing] the important contributions made by an accomplished Indiana engineer, designer, fabricator, or builder, and displays distinctive engineering and aesthetic characteristics."

**Builta-Rhode Farm (IHSSI #171-513-05008, 9500 State Road 55)**, is a Craftsman-style house built c. 1920. A barn and a Folk Victorian-style gable front house are also associated with the property. Builta-Rhode Farm belonged to Lee Builta and his wife, Bessie Rhode Builta, a member of the Rhode family, a prominent family within Pine Village. Lewis Rhode was born in Wayne County, Indiana on December 10, 1816. He moved with his father, William, to Warren County in 1827. A farmer by trade, like most of his family, he was also, at various points in his life, township clerk, justice of the peace, and township trustee for Pine Village. His son Thomas Rhode, born June 8, 1849 in Warren County, inherited the family farming business. Thomas' daughter Bessie, born August 24, 1877, married Lee Paris Builta in 1906. Lee, born November 3, 1876, was a preacher and printer by training, but inherited the farming trade when he married into the Rhode family. Bessie's father owned the land on which the Builta-Rhode Farm sits in 1904. When he died in 1919, Bessie inherited the farm. She and her husband owned the farm for the rest of their lives. Lee died on July 29, 1954; his wife died on February 18, 1970. At that point, the home fell into the hands of their son, Thomas Rhode Builta, born July 29, 1911. On May 12, 2001, several months before his death on October 3, 2001, the Builta-Rhode Farm and its contents were sold at auction. This resource is recommended eligible for listing in the NRHP under Criterion C because the main farmhouse embodies distinctive characteristics of the Craftsman architectural style.

**Pine Village Methodist Church (IHSSI #171-513-06007, 106 Church St.)**, is a church with Gothic Revival and Italianate elements built in 1885 with a sanctuary addition constructed in 1903. The Methodist Church was the first church organized in Pine Village in 1831. Congregants met in each other's homes for the first 14 years of the congregation's existence. In 1845, the first dedicated church structure for Pine Village's Methodist community was built. A second was constructed in 1885 to accommodate an expanded congregation. This second church is the Pine Village Methodist Church described here. Alterations were made to the structure in 1903, including the addition of a sanctuary. The entire structure has remained largely untouched ever since, and is a significant example of Gothic Revival architecture in Warren County. The Pine Village Methodist Church is a visually-striking structure that retains its historic character. It possesses many elements of its original vernacular design. As per Criteria Consideration A, though it is a religious institution, the resource is eligible due to its architectural significance. This resource is recommended eligible for listing in the NRHP under Criterion C because the resource is a largely untouched and visually striking example of Gothic Revival and Italianate architecture within Warren County.

**Pine Village Post Office (IHSSI #171-513-06004, 101 N Jefferson St.)**, opened in 1969, was built according to design standards laid out by the United States Postal Service. The structure is a variation on the Colonial Revival style of post offices. As part of the "Thousand Series" of post office design, which created standards of design for post offices between 1,000 and 12,000 square feet, an emphasis was placed on efficient interior design with minimal exterior ornamentation. The Colonial Revival style as expressed in the "Thousand Series" guidelines possesses only minimal elements of what is traditionally considered Colonial Revival architecture. The Pine Village Post Office exhibits only minimal elements of the Colonial Revival style, notably the brick exterior walls, single story, and gable-front three-bays wide with inset porch structure. This resource is recommended eligible for listing in the NRHP under Criterion A due to its significance in the area of Community Planning and Development, specifically the consolidation of the postal service as part of the rise of

suburbia. Further, the National Park Service has recommended that most or all post offices are eligible for the NRHP.

Knights of Pythias Building (IHSSI #171-513-06005, 110 E Lafayette St.), is an Italianate-style commercial building constructed c. 1900. This was a former lodge of the Knights of Pythias with retail shops using the bottom floors. The Knights of Pythias was founded in February 1864 by Justus H. Rathbone, a music composer and actor, to foster friendships through a charitable brotherhood. It was the first fraternal order chartered by an act of Congress and is thus significant in the history of fraternal orders in the United States. Like most small towns in Indiana, the Knights of Pythias constructed this building to house retail businesses on the ground floor and their own lodge upstairs. This resource is recommended eligible for listing in the NRHP under Criterion A for its association with the Knights of Pythias, one of the oldest fraternal orders within the United States, and under Criterion C because the structure embodies distinctive characteristics of the Italianate architectural style within commercial construction.

#### 4. DESCRIBE THE UNDERTAKING'S EFFECT ON HISTORIC PROPERTIES

**INDOT Bridge No. 26-86-1572** – The project will have "No Adverse Effect" on the INDOT Bridge No. 26-86-1572. No right-of-way is anticipated to be acquired at the bridge. Further, there is a proposed paving exception at the bridge. Work surrounding the bridge will involve only widening and resurfacing of the roadway on either side of the bridge.

**Builta-Rhode Farm, 9500 State Road 55** – The project will have "No Adverse Effect" on the Builta-Rhode Farm. No right-of-way is anticipated to be acquired from this property. The proposed project will involve roadway resurfacing and the widening of the road's shoulders adjacent to the southwest corner of the property.

**Pine Village Methodist Church, 106 Church St.** – The project will have "No Adverse Effect" on the Pine Village Methodist Church. No right-of-way is anticipated to be acquired from the proposed historic boundary of the church, which is located approximately 130 feet east of the project limits. However, right-of-way will be taken on the northeast corner of Church St. and SR 26, which is property that the church recently acquired. Prior to the church's acquisition of that property, there was a house located on it; however, that house has since been demolished. There will be resurfacing of the roadway on SR 26 and shoulder widening north of Church St. To the south of Church St., the placement of new curbs has been proposed and the curb ramp on the southeast corner of the intersection of SR 26 and Church St. is being replaced. In addition, representatives of the church have planned to construct new sidewalks on the north side of Church St. from the church to the northeast corner of the intersection of SR 26 and Church St. after the project is complete. No historic elements of the church will be affected by any of this work.

**Pine Village Post Office, 101 N Jefferson St.** – The project will have "No Adverse Effect" on the Pine Village Post Office. No right-of-way is anticipated to be acquired from this resource. The project involves roadway resurfacing with the addition of new curbs. The existing modern driveway to the post office will be replaced and a new storm sewer inlet will be installed. Because there are no existing curb ramps located at the intersection of SR 26 and Jefferson St., new curb ramps will be installed at all four corners of the intersection. The existing pull-off from the roadway on SR 26 in front of the U.S. Postal Service mailbox will be maintained. The mailbox will remain in place.

**Knights of Pythias Building, 110 E Lafayette St.** – The project will have "No Adverse Effect" on the Knights of Pythias Building. No right-of-way is anticipated to be acquired from this property. All work will occur on the curb face in front of the building. The project involves the installation of one new inlet in the curb and sidewalk that will be notched out and replaced. The existing modern sidewalk will be replaced. The existing roadway will be resurfaced; parking will be modified from angled pull-in spots to parallel parking spots on both sides of the street; and there will be updates to the pavement markings. None of these project elements will alter historic features of the Knights of Pythias Building.

## **5. EXPLAIN APPLICATION OF CRITERIA OF ADVERSE EFFECT – INCLUDE CONDITIONS OR FUTURE ACTIONS TO AVOID, MINIMIZE OR MITIGATE ADVERSE EFFECTS**

According to 36 CFR 800.5(a)(1) "An adverse effect is found when an undertaking may alter, directly or indirectly, any of the characteristics of a historic property that qualify the property for inclusion in the NRHP in a manner that would diminish the integrity of the property's location, design, setting, materials, workmanship, feeling or association."

INDOT Bridge No. 26-86-1572 - The project will have "No Adverse Effect" on the resource.

Per 36 CFR 800.5(a)(2)(i), "Physical destruction of or damage to all or part of the property" will not occur. No right-of-way is anticipated to be acquired at the bridge. A paving exception will occur on either side of the bridge.

Per 36 CFR 800.5(a)2(ii), "Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization, hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties and/or other applicable guidelines" will not occur. While the roadway near the bridge will be widened and resurfaced, none of this work will have an impact the historic elements of the bridge.

Per 36 CFR 800.5(a)2(iii), "Removal of the property from its historic location" will not occur. The project will not remove the property from its historic location.

Per 36 CFR 800.5(a)2(iv), "Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance" will not occur. There will be no change of character of the bridge's use since there will be a paving exception on either side of the bridge. Project elements, including widening of the shoulders and resurfacing of the existing roadway will not change any features that contribute to its historic significance or the property's use.

Per 36 CFR 800.5(a)2(v), the "Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features" will not occur. The proposed undertaking involves the widening of the shoulders and resurfacing of the existing roadway. While the introduction of these project elements will affect the setting of the bridge, it will not dimmish the integrity of its significant historic features.

Per 36 CFR 800.5(a)2(vi), "Neglect of a property which causes its deterioration..." will not occur as a result of this project. The undertaking will not cause neglect of the property.

Per 36 CFR 800.5(a)2(vii), the "Transfer, lease, or sale of property out of Federal ownership or control..." will not occur. Ownership of the historic property will not change as a result of this project.

Builta-Rhode Farm – The project will have "No Adverse Effect" on the resource.

Per 36 CFR 800.5(a)(2)(i), "Physical destruction of or damage to all or part of the property" will not occur. No right-of-way is anticipated to be acquired from this property.

Per 36 CFR 800.5(a)2(ii), "Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization, hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties and/or other applicable guidelines" will not occur. While the roadway will be widened and resurfaced adjacent to the southwest corner of the Builta-Rhode Farm, none of the proposed work will have an impact the historic elements of the property.

Per 36 CFR 800.5(a)2(iii), "Removal of the property from its historic location" will not occur. The project will not remove the property from its historic location.

Per 36 CFR 800.5(a)2(iv), "Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance" will not occur. No right of way will be taken from the property. The proposed undertaking involves the widening of the shoulders and resurfacing of the existing roadway adjacent to the southwest corner of the property, resulting in no change to any physical features within the property's setting that contribute to its significance.

Per 36 CFR 800.5(a)2(v), the "Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features" will not occur. The proposed undertaking involves the widening of the shoulders and resurfacing of the existing roadway adjacent to the southwest corner of the property. While the introduction of these project elements will affect the setting of the Builta-Rhode Farm, it will not dimmish the integrity of its significant historic features.

Per 36 CFR 800.5(a)2(vi), "Neglect of a property which causes its deterioration..." will not occur as a result of this project. The undertaking will not cause neglect of the property.

Per 36 CFR 800.5(a)2(vii), the "Transfer, lease, or sale of property out of Federal ownership or control..." will not occur. Ownership of the historic property will not change as a result of this project.

Pine Village Methodist Church - The project will have "No Adverse Effect" on the resource.

Per 36 CFR 800.5(a)(2)(i), "Physical destruction of or damage to all or part of the property" will not occur. No right-of-way is anticipated to be acquired from the proposed historic boundary of the property.

Per 36 CFR 800.5(a)2(ii), "Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization, hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties and/or other applicable guidelines" will not occur.

Per 36 CFR 800.5(a)2(iii), "Removal of the property from its historic location" will not occur. The project will not remove the property from its historic location.

Per 36 CFR 800.5(a)2(iv), "Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance" will not occur. No changes to historic features will occur near or within the property. The project elements that will occur one lot, approximately 130 feet, west of the Pine Village Methodist Church will not cause a change of character to any of its features.

Per 36 CFR 800.5(a)2(v), the "Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features" will not occur. Changes in viewshed one lot, approximately 130 feet, west of the Pine Village Methodist Church will be insignificant.

Per 36 CFR 800.5(a)2(vi), "Neglect of a property which causes its deterioration..." will not occur as a result of this project. The undertaking will not cause neglect of the property.

Per 36 CFR 800.5(a)2(vii), the "Transfer, lease, or sale of property out of Federal ownership or control..." will not occur. Ownership of the historic property will not change as a result of this project.

Pine Village Post Office - The project will have "No Adverse Effect" on the resource.

Per 36 CFR 800.5(a)(2)(i), "Physical destruction of or damage to all or part of the property" will not occur. No right-of-way is anticipated to be acquired at the Pine Village Post Office.

Per 36 CFR 800.5(a)2(ii), "Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization, hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties and/or other applicable guidelines" will not occur. The project involves roadway resurfacing with the addition of new curbs. The existing modern driveway to the post office will be replaced and a new storm sewer inlet will be installed. New curb ramps will be installed at all four corners of the intersection of SR 26 and Jefferson St. The existing pull-off from the roadway on SR 26 in front of the U.S. Postal Service mailbox will be maintained. The mailbox will remain in place, resulting in no alterations to historic elements of the property. No right-of-way will be acquired from the Pine Village Post Office.

Per 36 CFR 800.5(a)2(iii), "Removal of the property from its historic location" will not occur. The project will not remove the property from its historic location.

Per 36 CFR 800.5(a)2(iv), "Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance" will not occur. The project elements involve roadway resurfacing with the addition of new curbs, replacing the existing modern driveway to the post office, installation of a new storm sewer inlet, and new curb ramps will be installed at all four corners of the intersection of SR 26 and Jefferson St. Additionally, the existing modern pull-off from the roadway on SR 26 in front of the U.S. Postal Service mailbox will be maintained. The mailbox will remain in place. Because the modern driveway and pull-off are not considered to be a physical feature that contributes to the property, the impacts will not diminish the integrity of the property's significant historic features. The remaining elements of the project will not change the character of the property's use nor will they diminish the integrity of the property's historic features.

Per 36 CFR 800.5(a)2(v), the "Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features" will not occur. The project elements involve roadway resurfacing with the addition of new curbs, replacing the existing modern driveway to the post office, installation of a new storm sewer inlet, and new curb ramps will be installed at all four corners of the intersection of SR 26 and Jefferson St. Additionally, the existing modern pull-off from the roadway on SR 26 in front of the U.S. Postal Service mailbox will be maintained. The mailbox will remain in place. The introduction of these visual project elements will not diminish the integrity of the Pine Village Post Office's significant historic features.

Per 36 CFR 800.5(a)2(vi), "Neglect of a property which causes its deterioration..." will not occur as a result of this project. The undertaking will not cause neglect of the property.

Per 36 CFR 800.5(a)2(vii), the "Transfer, lease, or sale of property out of Federal ownership or control..." will not occur. Ownership of the historic property will not change as a result of this project.

Knights of Pythias Building – The project will have "No Adverse Effect" on the resource.

Per 36 CFR 800.5(a)(2)(i), "Physical destruction of or damage to all or part of the property" will not occur. No right-of-way is anticipated to be acquired from this property.

Per 36 CFR 800.5(a)2(ii), "Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization, hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties and/or other applicable guidelines" will not occur. All work will occur on the curb face in front of the building. The project involves the installation of one new inlet in the curb and sidewalk that will be notched out and replaced. The existing roadway will be resurfaced; parking will be modified from angled pull-in spots to parallel parking spots on both sides of the street; and there will be updates to the pavement markings. None of these project elements will alter historic features of the Knights of Pythias Building.

Per 36 CFR 800.5(a)2(iii), "Removal of the property from its historic location" will not occur. The project will not remove the property from its historic location.

Per 36 CFR 800.5(a)2(iv), "Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance" will not occur. All work will occur on the curb face in front of the building. The project involves the installation of one new inlet in the curb and sidewalk that will be notched out and replaced. The existing modern sidewalk will be replaced. The existing roadway will be resurfaced; parking will be modified from angled pull-in spots to parallel parking spots on both sides of the street; and there will be updates to the pavement markings. Because the existing modern roadway and sidewalk are not considered to be physical features that contribute to the Knights of Pythias Building, the impacts will not diminish the integrity of its significant historic features nor will it change of the character of its use.

Per 36 CFR 800.5(a)2(v), the "Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features" will not occur. The project will not introduce elements that diminish the historic features of the property. All work will occur on the curb face in front of the building. The project involves the installation of one new inlet in the curb and sidewalk that will be notched out and replaced. The existing modern sidewalk will be replaced to the east toward Jefferson St. The existing roadway will be resurfaced; parking will be modified from angled pull-in spots to parallel parking spots on both sides of the street; and there will be updates to the pavement markings. Because the existing modern streetscape is not considered to be a historic element of the Knights of Pythias Building, the impacts to the streetscape will not diminish the integrity of its significant historic features.

Per 36 CFR 800.5(a)2(vi), "Neglect of a property which causes its deterioration..." will not occur as a result of this project. The undertaking will not cause neglect of the property.

Per 36 CFR 800.5(a)2(vii), the "Transfer, lease, or sale of property out of Federal ownership or control..." will not occur. Ownership of the historic property will not change as a result of this project.

#### 6. SUMMARY OF CONSULTING PARTIES AND PUBLIC VIEWS

On September 25, 2019, an Early Coordination Letter (ECL) was distributed to consulting parties inviting them to participate in the Section 106 process.

On September 27, 2019, the Pokagon Band of Potawatomi Indians accepted consulting party status.

On October 15, 2019, the SHPO responded to the early coordination letter, stating that they were unaware of any additional parties who should be invited to participate in the Section 106 consultation on this project.

A Historic Property Report (HPR) was completed for the project (Wood, October 2020). The report distribution letter dated October 6, 2020 and HPR were distributed on that same day to participating consulting parties as well as inviting the property owners of the recommended historic properties.

On October 12, 2020, Ethan Foxworthy, the chairman of the administrative council for the Pine Village United Methodist Church, asked: "Out near the road of State Road 26 there are some limestone blocks for a retaining wall that is there. Are they planning on removing those and then making a new retaining wall, not going to do anything with it as just accepting the land for Right of Way, or another option? We are fearful without knowing what is to be done, that the ground will settle and force out the dirt therefore leading us to handle a costly fix down the road."

Alex Kline, with Infrastructure Engineering, Inc., responded via email: "As of right now, we are not planning on impacting these limestone blocks. They appear to be located just within the state's ROW. Currently, the town's storm sewer system empties into this ditch on the east side of the roadway, but in the proposed condition, it will drain to the west side of the roadway and the existing ditch will be regraded with less water coming to it."

Ethan's Response: "I believe that answers the biggest question of ours. Also another brief question, the Town of Pine Village has been on us of adding a sidewalk back from the church building location towards the intersection of Church St. to SR55. There was a deteriorated one there when we bought the property and currently we have gravel for parking. Our goal is to place a sidewalk down toward the corner and add pavement on the outside towards the street. As the Town has been on us about it, we were informed of this project last year or one similar to it that they would be placing crosswalks on the intersections and we chose to push off our project till this one was completed. In our minds, we don't want to place our sidewalk down to the corner and then in the end not match up with the crosswalks on the corner when they are completed. Is that a safe assumption for us to forward on to the town for us not completing that project until the INDOT project is completed?"

Alex's Response: "This is a little more difficult question to answer. At this particular corner, there are no plans to add a curb ramp for your sidewalk to connect to at this point in time as these are only installed where there is sidewalk present. That's not to say we couldn't evaluate adding it to the project if you commit to installing sidewalk in the future. I will need to discuss this with the INDOT project manager to make sure that INDOT will pay for this curb ramp. This project is tied to a funding source that may or may not allow for improvements of this kind. If this is approved, we will need to know how far from the existing roadway you plan to install the sidewalk so we can design the curb ramp to receive it."

Ethan's Response: "That is also a difficult question to answer as we were going to add the sidewalk after your curb ramp so we would know exactly where to put it at. We are all ready to go as our council has already approved doing the sidewalk with the condition that yours was added so we knew exactly where to place it at. I assume that you have to place it in a specific location so far from either road maybe? So that is why we were kind of waiting to see where you placed it so we could then pour ours to match up with yours."

Alex's Response: "Typically there is a 3'-5' buffer between the edge of the roadway and the sidewalk, but as you mentioned there is currently a lot of gravel in this area. I would recommend coordinating with someone in the Town of Pine Village to see if they have any requirements or recommendations for local roadways. If not, I would ask that you tell me your preference. Ultimately, we want to make sure that if we build it that it works with your plans and accommodates any changes you plan to make to your property/parking down the road. The proposed curb ramp would need to be located across Church St so that it lines up with the sidewalk that is already present on the East side of SR 26/SR 55. I just heard back from the INDOT project manager and the state does not plan to add a curb ramp at this location because there is not existing sidewalk to connect to. There is some concern with installing this in advance and it not connecting to your sidewalk properly while also meeting ADA requirements. They have recommended that the sidewalk and curb ramp be installed at the completion of the work on SR 26/SR 55."

On November 4, 2020, SHPO stated that the APE appeared of adequate size for the project. They also agreed with the conclusions of the HPR that the Builta-Rhode Farm (IHSSI #171-513-05008), Pine Village Methodist Church (IHSSI #171-513-06007), Pine Village Post Office (IHSSI #171-513-06004), and INDOT Bridge No. 26-86-1572 (IHSSI #171-513-10008; HB-1758; NBI #6620) were eligible for inclusion in the NRHP. Regarding INDOT Bridge No. 26-86-1572 (IHSSI No. 171-513-10008; HB-1758; NBI #6620), SHPO noted the possible paving exception near the bridge. SHPO further agreed that the house at 102 S. Main Street (IHSSI #171-513-060019) was not eligible for inclusion in the NRHP. However, SHPO disagreed with the conclusions in the HPR regarding the Knights of Pythias Building (IHSSI #171-513-06005), stating their belief that the property retained enough integrity to merit its eligibility for listing in the NRHP.

With regard to archaeological resources, an Archaeology Report was completed for the project (Jackson, March 11, 2021). It has been distributed with the effect finding/800.11 documentation.

The report distribution letter accompanying this 800.11 documentation has invited the following property owners of the NRHP-eligible Knights of Pythias Building to become consulting parties:

- Theodore and Darlene Schutter, property owners of Knights of Pythias Building, 108 E. Lafayette St.
- The Windy Mill LLC, property owner of Knights of Pythias Building, 110 E. Lafayette St.
- Dennis Brummett, property owner of Knights of Pythias Building, 116 E. Lafayette St.

None of the other consulting parties provided any additional comments regarding the early coordination letter or HPR. Please see Appendix C for Consulting Party Correspondence.







A historian who meets the Secretary of the Interior's Professional Qualification Standards identified and evaluated above-ground resources within the APE for potential eligibility for the NRHP. As a result of the historic property identification and evaluation efforts, three above-ground resources are recommended as eligible for listing in the NRHP:

- Builta-Rhode Farm (IHSSI No. 171-513-05008), 9527-9543 North SR 26
- Pine Village Methodist Church (IHSSI No. 171-513-06007), 106 E. Church St.
- Pine Village Post Office (IHSSI No. 171-513-06004), 101 N. Jefferson St.

An archaeologist who meets the Secretary of the Interior's Professional Qualification Standards is conducting a survey of archaeological resources within the APE for potential eligibility for listing in the NRHP. A report of



that investigation is forthcoming and will be distributed to the appropriate consulting parties for review at a later date.

On September 27, 2019, the Pokagon Band of Potawatomi Indians accepted consulting party status.

On October 15, 2019, the Indiana State Historic Preservation Officer (SHPO) staff stated that they "were not aware of any parties who should be invited to participate in the Section 106 consultation on this federal undertaking, beyond those whom INDOT already has invited. However, if right-of-way is likely to be taken from a potentially historic property, it might be advisable to invite the owner of that property as soon as possible. In your next regular correspondence on this project, please advise us as to which of the invited consulting parties has accepted the invitation."

*Response:* The property owners of the potentially historic properties have been invited to be consulting parties. They have been added to the Distribution List below.

#### INTERPRETATIONS OF THE FINDINGS INTO A REGIONAL CONTEXT

Three archaeological sites (12-Wa-299, 12-Wa-300, and 12-T-1244) were documented by this investigation. These can be broken down into two isolated finds (12-Wa-299 and 12-Wa-300) and one lithic scatter (12-T-1244).

Because these sites are a small lithic scatter or isolated finds, it can be surmised that these were ephemeral sites that were inhabited/utilized for a very brief period of time.

As shown in Table 1, prehistoric sites in this region are primarily small lithic scatters or isolated finds, which concurs with the results of this investigation.

From the prehistoric diagnostic artifacts, it can be determined that this region was utilized during the Early Archaic and Terminal Archaic temporal periods. This is not surprising for several of the sites in the study area date to these temporal periods; it should be noted that in some cases Terminal Archaic and Late Archaic are interchangeable periods.

The scarcity of prehistoric sites within the survey area was to be expected due to the lack of lithic resources (no chert outcrops are located either in or in close proximity to the survey area), the relative lack of ecozones east of the Town of Pine Village where nearly all of the survey area is located on ground moraine, and the lack of water (except for Holder Ditch, no permanent drainages are crossed by the survey area that is east of Pine Village, while the only permanent drainage that was surveyed by this investigation west of the town was adjacent to Mud Pine Village). Due to this lack of resources, prehistoric usage of the survey area would have consisted of small hunting groups that would have had ephemeral and temporary campsites.

Therefore, the data collected by this investigation for the prehistoric usage of this area is what one would expect. Small campsites or isolated finds that are indicative of ephemeral and temporary occupations, and that due to the distance from water resources, this area would have been utilized during the Early Archaic period.

### SUMMARY AND CONCLUSIONS

In March 2019, Infrastructure Engineering contracted SJCA to conduct a Phase Ia archaeological records review and reconnaissance survey for the proposed SR 26 Road Rehabilitation project (Des 1400249) in Tippecanoe and Warren Counties, Indiana. The proposed project will commence at the intersection of SR 26 and U.S. Highway 41 in Warren County and run in an easterly direction terminating in Tippecanoe County approximately 0.16-miles east of the border between the two counties.

The Tippecanoe County portion of the survey area is in Sections 10 and 15,

Township 22, and 23, Range 6 West, Shelby Township. The Warren County portion is in Sections 3 to 5 and 7 to 12, Township 23 North, Range 8 West, Pine Township; Sections 7 to 11, Township 23 North, Range 7 West, Adams Township; Sections 11 and 12, Township 23 North, Range 7 West, Medina Township; and Sections 7 to 16, Township 23 North, Range 6 West, Medina Township. It should be noted that the eastern half of Section 11, Township 23 North, Range 7 West is in Medina Township, while the western half is in Adams Township.

The survey area is approximately 15.8 miles in length and has a maximum width of 0.3 miles and encompasses approximately 143 acres.

The records review indicated that no section of the survey area in which additional right-of-way would be taken had been previously surveyed, and it was also ascertained that no sites had been recorded in those sections.

It was determined that several sections of the survey area that were visually inspected during the original Phase Ia archaeological investigation, needed to be reexamined. These sections entailed possible undisturbed areas within the existing rightof-way. Fieldwork commenced on these sections on January 29, 2021. However, inclement weather (snowstorm and freezing temperatures) occurred shortly after fieldwork began. Updated guidance concerning possible undisturbed areas within the existing right-of-way was provided by the Cultural Resources Office of the Indiana Department of Transportation on February 26, 2021. It was determined that only the potentially eligible previously recorded sites (12-Wa-253 and 12-Wa-259) will require field investigations for this project. It will not be necessary to investigate the other areas of undisturbed right-of-way that has been identified within the HMA overlay sections of the project. For those sections it will be sufficient to explain that the proposed project activities will be limited to the already paved portion of the roadway, and that a visual inspection of the existing right-of-way showed the adjacent portions to be previously disturbed.

The field investigation documented three sites (12-Wa-299, 12-Wa-300, and 12-T-1244). These sites consisted of two isolated finds and one small lithic scatter. Based on the data obtained from the field investigation, it is recommended that none of these sites are eligible for listing on the NRHP and that no further archaeological work should be undertaken on them.

Fieldwork was undertaken at the recorded location of site 12-Wa-253 within the existing right-of-way. No evidence of the site was found. It was also ascertained that all of site 12-Wa-259 within the existing right-of-way has been destroyed; however, a vast majority of the site, which includes the mound, is situated outside of the existing right-of-way and will not be impacted by the proposed project. Visual inspection of the site area and that a tree has been removed from the mound.

Based on the data obtained from this investigation, it can be ascertained that the proposed project will not impact any archaeological resources that are potentially

eligible for placement on the NRHP under Criterion D. It is therefore recommended that the proposed project should proceed.

It should be noted that if any prehistoric or historic archaeological artifacts or human remains are uncovered during construction, demolition, or earthmoving activities, state law (Indiana Code 14-21-1-27 and -29) requires that the discovery needs to be reported to the Indiana Department of Natural Resources, Division of Historic Preservation and Archaeology within two business days, as well as to the Cultural Resources Office of the Indiana Department of Transportation. Be advised that adherence to Indiana Code 14-21-1-27 and -29 does not obviate the need to adhere to applicable federal statutes and regulations, including but not limited to 36 C.F.R. Part 800.

Pursuant to Section 106 of the National Historic Preservation Act of 1966, as amended (54 U.S.C. § 306108), implementing regulations at 36 C.F.R. Part 800, and the "Programmatic Agreement (PA) Among the Federal Highway Administration, the Indiana Department of Transportation, the Advisory Council on Historic Preservation and the Indiana State Historic Preservation Officer Regarding the Implementation of the Federal Aid Highway Program in the State of Indiana," the staff of the Indiana State Historic Preservation Officer ("Indiana SHPO") has reviewed your March 16, 2021 submission which enclosed the aforementioned archaeology report and INDOT's finding and documentation for the aforementioned project, received by our office March 19, 2021.

As previously indicated, we note that the INDOT Bridge No. 26-86-1572 (HB-1758), the Bulita-Rhode Farm (Indiana Historic Sites and Structures Inventory ["IHSSI"] #171-513-05008), the Pine Village Methodist Church (IHSSI #171-513-06007), the Pine Village Post Office (IHSSI #171-513-06004), and the Knights of Pythias Building (IHSSI #171-513-06005) are the only historic properties eligible for inclusion in the National Register of Historic Places ("NRHP") located within the project's area of potential effects.

In terms of archaeological resources, as previously indicated, based upon the submitted information and the documentation available to the staff of the Indiana SHPO, we have not identified any currently known archaeological resources listed in or eligible for inclusion in the National Register of Historic Places ("NRHP") within the proposed project area. We concur with the opinion of the archaeologist, as expressed in the Phase Ia archaeological literature review and reconnaissance survey report (Jackson, 03/10/2021), that archaeological sites 12-Wa-0299, 12-Wa-0300, and 12-T-1244 (all of which were identified during the archaeological investigations) do not appear to be eligible for inclusion in the NRHP, and that no further archaeological investigations appear necessary at these areas.

Additionally, based upon the submitted information and the documentation available to the staff of the Indiana SHPO, there is insufficient information regarding archaeological site 12-Wa-0259 (which was resurveyed during the archaeological investigations) to determine whether it is eligible for inclusion in the NRHP. However, we concur with the opinion of the archaeologist, that the portions of the site that lie within the proposed project area have been destroyed; and it is our understanding that the portions of the site that lie outside the proposed project area—portions which include a mound—will be avoided by all project-related ground-disturbing activities. The remaining, intact portions of Site 12-Wa-0259 should be clearly

marked and must be avoided by all ground-disturbing project activities. If the project is altered to include any portions of site 12-Wa-0259, and if avoidance is not feasible, then additional archaeological investigations may be necessary. Any further archaeological investigations must be done in accordance with the "Secretary of the Interior's Standards and guidelines for Archeology and Historic Preservation" (48 F.R. 44716).

If any prehistoric or historic archaeological artifacts or human remains are uncovered during construction, demolition, or earthmoving activities, state law (Indiana Code 14-21-1-27 and Indiana Code 14-21-1-29) requires that the discovery be reported to the Indiana Department of Natural Resources, Division of Historic Preservation and Archaeology within two (2) business days. In that event, please call (317) 232-1646. Be advised that adherence to Indiana Code 14-21-1-27 and Indiana Code 14-21-1-29 does not obviate the need to adhere to applicable federal statutes and regulations, including but not limited to 36 C.F.R. Part 800.

Accordingly, we concur with INDOT's March 15, 2021, Section 106 finding of "No Adverse Effect" on behalf of FHWA for this federal undertaking.

The archaeological reviewer for this project on the Indiana SHPO staff is Wade T. Tharp and the structures reviewer is Danielle Kauffmann. 





**Underground Storage Tank (UST) Sites:** Four (4) underground storage tanks are located within the 0.5 mile search radius. Three (3) of the four (4) USTs are mapped adjacent to the project.

The Herrman & Goetz Site, AI #30509, is mapped adjacent to the project, but the company name and AI number return a site in South Bend in the IDEM Virtual File Cabinet. No impact is expected.

**NPDES Facilities:** Two (2) NPDES facilities are mapped within the 0.5 mile search radius. Both facilities are described as part of the Pine Village Wastewater Collection and Treatment System. One facility is shown at the east junction of SR 26 and SR 55, within the project limits. However, aerial photography shows the treatment plant is located behind the Pine Village Elementary School – 0.23 mile north of the project. No impact is expected.

**NPDES Pipe Locations:** One (1) NPDES pipe location is within the 0.5 mile search radius. The Pine Village Wastewater Treatment Plant outfall is located 0.30 mile north of the east end of the project, along Big Pine Creek. No impact is expected.

#### **ECOLOGICAL INFORMATION SUMMARY**

#### **PROJECT DESCRIPTION**

The proposed project involves hot mix asphalt (HMA) overlay on SR 26, from 0.33 mile east of the east junction with SR 55 to 0.15 mile east of the Warren and Tippecanoe County Line, utilizing funding from the Federal Highway Administration (FHWA). Project elements include widening of shoulders, addressing pavement maintenance issues, and extending or replacing existing culverts/maintenance pipes as needed based on hydraulic analysis. One reinforced concrete slab bridge (Str. 026-86-05817 B) will be widened or replaced. The 5' x 7' reinforced concrete box (CV 026 86 23.24) over the Gephart Magett Ditch was recently replaced and will not require resizing or replacement as part of this project. Additional maintenance pipes may be added as part of this project.

#### **Explanation:**

**Underground Storage Tank (UST) Sites:** Four (4) underground storage tanks are located within the 0.5 mile search radius, and all are located in Pine Village. One (1) of the four (4) USTs is located adjacent to the project, at Pine Village Elementary School (Pine Village Elementary School, 3756 E SR26 Pine Village, IN, 47975, AI #50406). The school UST was closed on September 9, 1996 and closure samples indicate a clean closure. No impact is expected.

**NPDES Facilities:** Two (2) NPDES facilities are mapped within the 0.5 mile search radius. The Warren and Tippecanoe County listings of the Indiana Natural Heritage Data Center information on endangered, threatened, or rare (ETR) species and high quality natural communities is attached with ETR species highlighted. A preliminary review of the Indiana Natural Heritage Database by INDOT SAM during the RFI review period did indicate the presence of endangered species. Coordination with USFWS and IDNR will occur.

**Bat Protocol:** A review of the USFWS database indicated the presence of endangered bat species in or within 0.5 mile of the project area, additional coordination with INDOT ES will be necessary.
