LEGAL NOTICE OF PUBLIC HEARING – DES# 1383615 Proposed intersection improvement at S.R. 55 and 73rd Avenue Merrillville, Lake County

The Troyer Group, in coordination with the Indiana Department of Transportation (INDOT), will host a public hearing on Thursday October 22, 2020 at Merrillville High School: 276 E. 68th Place. Merrillville, IN 46410: Freshman Center Lecture Hall - Entrance J. The hearing will begin at 6:00 p.m. Prior to the official public hearing, project representatives will be available during a project open house from 5–6 p.m. Following the public hearing, a second project open house will occur from 6:45–7:30 p.m. The purpose of the public hearing is to offer all interested persons an opportunity to comment on current preliminary design plans to modify the intersection at State Road (SR) 55 and 73rd Avenue Merrillville, Lake County. The need for this project stems from the intersection's inability to safely handle current and projected traffic. The intersection sees a high rate of traffic accidents due to the large volumes of traffic that pass through. The purpose of the proposed project is to increase operational safety at the intersection and to reduce the frequency and severity of vehicular accidents that occur at the intersection, while maintaining the operational efficiency in both the construction year and the horizon year.

The public hearing will follow Indiana State Department of Health (ISDH) guidance health and safety protocols, including project team members wearing face coverings and attendees wearing face coverings, providing hand sanitizer, providing ample access to handwashing facilities, implementing social distancing, and including monitoring the number of attendees participating to comply with local ordinances. Face coverings will be available for attendees who arrive without one.

For those wishing to participate in the hearing, but not attend in-person, the public hearing will be streamed live over the internet via Facebook Live from INDOT Northwest's Facebook page (https://www.facebook.com/INDOTNorthwest/).

As proposed, the project involves the conversion of the existing signalized intersection into a hybrid single-lane/dual-lane roundabout. The center of the roundabout would be shifted slightly southeast of the existing intersection's center. This will minimize impact to the businesses adjacent to the northeast, northwest, and southwest intersection quadrants.

All improved roadway surfaces along SR 55 and 73rd Ave within the proposed roundabout will be surrounded by concrete curb and gutter, which will drain into a new storm sewer system. The storm sewer system will drain stormwater generally from northwest to southeast where it will be collected into a proposed detention basin immediately southeast of the proposed roundabout. The basin will then empty eastward toward an unnamed tributary of Turkey Creek. Lighting improvements are also proposed as part of the project. All driveway aprons adjacent to the improved roadway will be reconstructed within proposed construction limits.

As proposed, the maintenance of traffic (MOT) for the project will be phased. Two-way traffic will be maintained along SR 55, while 73rd Ave. will be closed during some phases of construction.



During Phase I, the eastern portion of the project area will be closed, including 73rd Ave. east of the intersection. One northbound and one southbound lane of SR 55 will remain open and will be routed to the western side of the existing intersection. Eastbound 73rd Ave. traffic will be able to turn left or right onto SR 55, while westbound traffic will utilize the detour route. In Phase II, the intersection will be reopened entirely while portions of the SR 55 median are constructed. SR 55 will still consist of one northbound and one southbound lane, and 73rd Ave. will utilize the previously constructed portions of the proposed roundabout. Phase III will mirror phase I, with the SR 55 travel lanes being shifted to the eastern portion of the intersection, and westbound 73rd Ave. being closed to construction. The intersection closures will be in place for approximately one construction season, with a break in the middle for Phase II in which the intersection will be reopened. A detour will be implemented during Phases I and III. The official State detour will involve US 30, SR 53, and W. 61st Ave. and will be approximately 5.4 miles long. This will add roughly 2.9 miles of travel. The proposed improvement will require acquisition of approximately 1.72 acres of new permanent right-of-way, in addition to some temporary right-of-way needed during construction.

Additional project details will be presented during the public hearing and will be also made available via the INDOT website.

Construction is anticipated to begin June 1, 2022. Federal and state funds are proposed to be used for construction of this project. INDOT and the Federal Highway Administration have agreed that this project poses minimal impact to natural environment. A Categorical Exclusion (CE) environmental document has been prepared for the project. The environmental documentation and preliminary design information is available to view prior at the following location:
