LEGAL NOTICE PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) has developed preliminary plans for a proposed State Road (SR) 26 small structure replacement with a bridge over Goose Creek, 4.98 miles west of US 52/231, located in Tippecanoe County. The project extends 825 feet west and 200 feet east of the structure center. The project purpose is to replace the twin concrete box structures with a precast concrete 3-sided bridge. This project will also include, but is not limited to, constructing a paved access road down the existing fill slopes to provide future access for maintenance and inspection of the replacement structure.

The Maintenance of Traffic plan for this project is to be a road closure at SR 26 during the construction period. The official detour will be SR 55, SR 352, US 52, and US 231. The detour length is 24.5 miles. Access to all properties will be maintained throughout construction. Project stakeholders including local school corporation(s) and emergency services will be notified of potential closures and/or detours prior to any construction. The proposed start of construction is Spring 2024.

Construction of the project will require approximately 0.63 acre of new permanent right-of-way. An estimated cost of the project is \$4,803,368.00. Federal and state funds are to be utilized for the construction of the project. The Federal Highway Administration and INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion (CE) 2 environmental document with no significant impacts to stream resources.
