

## *HISTORIC PRESERVATION ADVISORY TEAMS*

Historic Preservation Advisory Teams (HPATs), which were established by the Section 106 Memorandum of Agreement (MOA), worked closely with designers and project officials to ensure that historic buildings, features and the historic character of affected areas were preserved.

### **OVERSIGHT**

HPATs were active on the project since design work began in Dec. 2003. According to the MOA, the role of the Kentucky and Indiana Historic Preservation Advisory Teams (KHPAT and IHPAT) was to “ensure the Project is designed in a manner that respects the historic qualities, landscapes, historic buildings and features within the Alternative Specific APE” (Area of Potential Effects).

The KHPAT and IHPAT provided input and made recommendations, which were submitted to the [Bi-State Historic Consultation Team \(BSHCT\)](#). The BSHCT, in turn, considered and determined recommendations to be sent to the Bi-State Management Team for approval.

Both advisory teams were co-chaired by representatives of the State Historic Preservation Office and state transportation agencies.
