LEGAL NOTICE OF PUBLIC HEARING

Lead Des. No. 1700108, 1902760, and 1900353

The Indiana Department of Transportation (INDOT) will host a public hearing on Wednesday April 27, 2022, at the Edinburgh High School Cafeteria, 300 S. Keeley St., Edinburgh, IN 46124. Doors will open at 5:30 p.m. and the hearing will begin at 6:00 p.m. The purpose of the public hearing is to offer all interested persons an opportunity to comment on current preliminary design plans for the pavement project on SR 252 from US 31 to 0.18 mile west of I-65 in Johnson and Shelby Counties, Indiana. The purpose of this project is to improve the poor pavement condition and design while improving drainage and providing a roadway cross section that meets American with Disabilities Act (ADA) requirements.

The preferred alternative for the Lead Des. No. 1700108 includes 4-inch functional inlay (milling the top 4 inches of existing hot mix asphalt (HMA) off and replacing it with 4 inches of new HMA) from US 31 to Eisenhower Dr. The bridge over Big Blue River is not included in this project and will be avoided. The pavement along SR 252 from Eisenhower Dr. to Lincoln St. will be reconstructed. The roadway will be widened, where feasible, to correct poor sight distance, pedestrian safety, and improve turning radii, which currently experiences vehicle and semi-truck encroachments onto properties and into on-coming traffic., The Louisville & Indiana Railroad is not included in this project and will be avoided. The existing stormwater facilities will be upgraded and repaired. Castings that are substandard and/or functionally obsolete will be replaced. New curb and gutter will be installed. New sidewalks and curbs will be installed, where none currently exist, on the south side of SR 252 from Eisenhower Dr. to Pleasant St. The existing sidewalks and ramps from pleasant St. to Lincoln St. will be upgraded in compliance with ADA. There will be a 2-inch functional inlay with Lincoln St. to 0.18 mile west of I-65. A storm sewer outlet will be installed on the north side of SR 252 to the Big Blue River, approximately 275 ft. east of Eisenhower Dr. The existing raised pavement markers (RPMs) will be replaced. New pavement markings, speed limit signs, stop signs with light emitting diode (LED) lights, and other instructional signs will be installed.

The preferred alternative for Des. No. 1902760 includes new sidewalks and curbs will be installed, where none currently exist, on the south side of SR 252 from Lincoln St. to Lind Dr. (CR 800 E). Two gravel drive approaches on the south side of SR 252, between Lincoln St. and CR 800 E, will be replaced with asphalt. New permanent lighting (43 poles) will be installed on both sides of SR 252, from Eisenhower Dr. to Lincoln St., a distance of approximately 5,650 ft. (1.07 miles). The existing cobra head lighting on power poles, located at the intersections, will be removed.

The preferred alternative for Des. No. 1900353 includes a 32 ft. x 5 ft. x 2.33 ft. 3-sided culvert (CV 252-041-29.94) with a corrugated metal pipe will be removed and replaced with a 42 ft. x 5 ft. x 4 ft. reinforced concrete box culvert.

From US 31 to Eisenhower Dr. all work will take place in existing right-of-way (ROW). The project requires approximately 2.82 acres of permanent ROW along SR 252 for road widening, tree removal, sidewalk and curb construction, and grading, from Eisenhower Dr. to approximately 100 feet east of the culvert replacement, of which 1.82 acres is residential, 0.38 acre is commercial, 0.16 acre is agricultural-grass, 0.35 acre is industrial, and 0.11 acre is institutional land use. One business and three residential properties may be relocated during this project. The project also requires approximately 1.32 acres of temporary ROW along SR 252 for driveway reconstruction and grading, from Eisenhower Dr. to Lincoln St., of which 0.88 acre is residential, 0.30 acre is commercial, 0.13 acre is industrial, and 0.01 acre is

institutional land use. Approximately 1.96 acres of permanent ROW will be reacquired in order to establish clear title from Eisenhower Dr. to Lincoln St. Lastly, approximately 0.11 acre of perpetual easement will be acquired to install the storm sewer outfall. Construction is anticipated to begin in October 2024.

The Federal Highway Administration (FHWA) and INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion Level 3. At present, both state and federal funds are anticipated for construction of the project with the total cost estimated at \$6,392,997. No significant adverse impacts to the human and natural environment were found during the creation of this document.
