## Public Information Meeting – SR 3 Pavement Replacement in Hartford City

### About this Event

LEGAL NOTICE OF PUBLIC INFORMATION MEETING Des. 2200805, State Road 3 (North Walnut Street) in Hartford City. The Indiana Department of Transportation (INDOT) will host a Public Information Meeting (PIM) to discuss planned improvements to traffic lanes and adjoining infrastructure. The PIM will be held on Monday, May 12 in the school cafeteria at Blackford Junior-Senior High School, 2392 North State Road 3, Hartford City, IN 47348.

Doors will open at 5:00 p.m. to give participants time to view displays and talk to representatives prior to the meeting. The formal presentation will begin at 5:30 p.m. The purpose of the PIM is to offer all interested persons an opportunity to review and comment on preliminary plans, including maps of impacted intersections and suggested detour routes during construction.

As proposed, the project is to provide improvements to a 1.3-mile stretch of the north side of Hartford City along Walnut Street (State Road 3) including full-depth pavement reconstruction between Franklin Street and Park Avenue and pavement resurfacing from Park Avenue to Huggins Drive. The project will require permanent and temporary right-of-way.

The purpose of this project is to extend the life of SR 3 by establishing a working surface drainage system and improving mobility and safety.

The Maintenance of Traffic (MOT) plan for the project involves a planned closure with recommended detours. MOT details will be presented during the meeting. Access to all properties will be maintained during construction. INDOT will coordinate with emergency services, local school corporation officials and project stakeholders to ensure potential disruptions and impacts are minimized as much as possible.

Representatives from the Indiana Department of Transportation, the city of Hartford City, AECOM, the consultant leading design improvements, and other key project members will provide information and gather feedback about the project.

Project resources, including a copy of the presentation and graphics, will be available on the INDOT website (<https://www.in.gov/indot/about-indot/central-office/welcome-to-the-fort-wayne-district/>) after the May 12, 2025 PIM. Project information will be available at Hartford City Public Library, 314 N. High St., Hartford City, IN 47348.

With advance notice, INDOT will provide special accommodation for persons with regards to participation and access to project information as part of the hearings process including arranging auxiliary aids, interpretation services for the hearing impaired, services for the sight impaired and other services as needed. In addition, INDOT will provide accommodations for persons of Limited English Proficiency (LEP) requiring auxiliary aids including language interpretation services and document conversion.
