LEGAL NOTICE PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) has developed preliminary plans for a proposed culvert replacement along State Route (SR) 234, 6.55 mi. west of SR 75 in Montgomery County. The existing structure consisting of three 2 ft. diameter corrugated metal pipes will be replaced with a 3 ft. tall x 6 ft. wide reinforced concrete box sumped 18 in. with Class I riprap placed at the outlet and revetment riprap placed at the inlet. The need for the project is to improve the safety, condition, and performance of this crossing to current standards and hydraulic requirements while extending the service life by at least 75 years.

The Maintenance of Traffic for the project will require a full closure of SR 234 with detour due to the type of work. The proposed official detour will utilize SR 75, SR 236, and US 231. The detour length is approximately 24 mi. It is anticipated that road closure will be required for approximately 2 months. Local roads may be used by local traffic. Access to all properties will be maintained throughout construction. Project stakeholders including local school corporations and emergency services will be notified of closures and detours prior to any construction. The proposed start of construction is fall 2022.

Construction of the project will require approximately 0.81-acre of permanent right-of-way (ROW). No temporary ROW will be required. No streams, wetlands, or other waters will be impacted by this project. The estimated cost of the project is \$377,041. Federal and state funds are to be utilized for the construction of the project. The Federal Highway Administration and INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion (CE) Level 2 environmental document.
