We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated July 21, 2017. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the:

- Area Plan Commission of Tippecanoe County (APCTC)
- Indiana Department of Transportation (INDOT)
- Indianapolis Metropolitan Planning Organization (IMPO)
- Michiana Area Council of Governments (MACOG)
