We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated February 8, 2019. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the:

- Northwestern Indiana Regional Planning Commission (NIRPC)
- Michiana Council of Governments (MACOG)
- Northeastern Indiana Regional Coordinating Council (NIRCC) (Fort Wayne)
