## RE: RESIDENT INPUT SURVEY AND INFORMATION MEETING

Dear Resident/Property Owner:

Indiana Department of Transportation (INDOT) is soliciting input from residents and property owners that would benefit from the construction of noise barriers for the Interstate 69 (I-69) Section 6 Project through Martinsville, in Morgan County. The project includes upgrading SR 37 to I-69 from south of Indian Creek north to Twin Branch Road and interchange construction at SR 39, Ohio Street, and SR 252/SR 44.

Noise barriers were determined to be feasible and cost effective on the west side of I-69 at three locations.

- 1. Noise Barrier NB1W I-69 southbound off-ramp to Morton Avenue/SR 39.
- 2. Nosie Barrier NB2W I-69 southbound between Burton Lane and Ohio Street.
- 3. Noise Barrier NB3WA/NB3WB –I-69 southbound north of Ohio Street between Grand Valley Boulevard and Ohio Street.

As part of the project development process, INDOT asks residents and property owners that would benefit from the construction of a noise barrier whether or not they want the barrier to be constructed. FHWA and INDOT will consider the feedback received before making a decision whether or not to construct each noise barrier. If a majority (greater than 50%) of benefited landowners or residents do not respond a second survey may be required. **INDOT needs your input on whether you want the proposed noise barrier constructed in your area. Please complete and return the enclosed survey card by March 29, 2019.** 

A meeting to discuss potential noise barriers will be held on March 12, 2019. The project team will present INDOT's noise mitigation process and proposed noise barrier locations. Project staff will be available to answer questions and solicit input from the public. Your attendance and participation are encouraged.

# NOISE BARRIER 1W I-69 SOUTHBOUND OFF-RAMP TO MORTON AVENUE/SR 39


