**April 1** - Distribution deadline for RMDs. Age 70.5 if born before July 1, 1949 otherwise age 72.

**April 18** - Federal & state taxes due.

**July 1** - Do a mid-year tax check-up & make adjustments as needed.

**Sept. 30** - Review Annual Notice of Change information sent by your Medicare plan.

**Oct. 24** - Log in to confirm the accuracy of your email & mailing address to ensure timely 1099 delivery.
