- Jan. 31** - 1099s postmarked & available online.
- Feb. 14** - Duplicate 1099s available.
- April 1** - Distribution deadline for RMDs.
- April 15** - Federal & state taxes due.
- June 19** - INPRS phone line closed. Office is open.
- July 1** - Mid-year tax check-up. Make adjustments online.
- Sept. 30** - Review Annual Notice of Change info from your Medicare plan.
- Oct. 24** - Confirm your email & mailing address to ensure timely 1099 delivery.
- Dec. 10** - Change direct deposit & address info by 5 p.m. for Jan. 2025.
