INVESTMENT OBJECTIVE

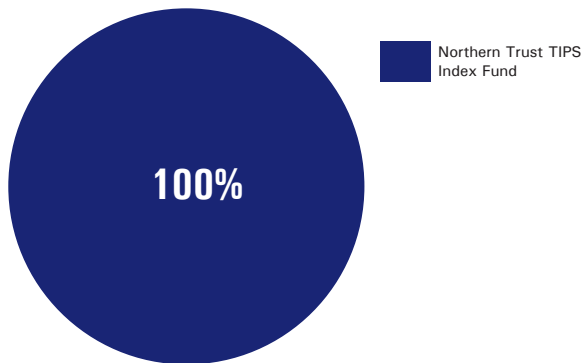

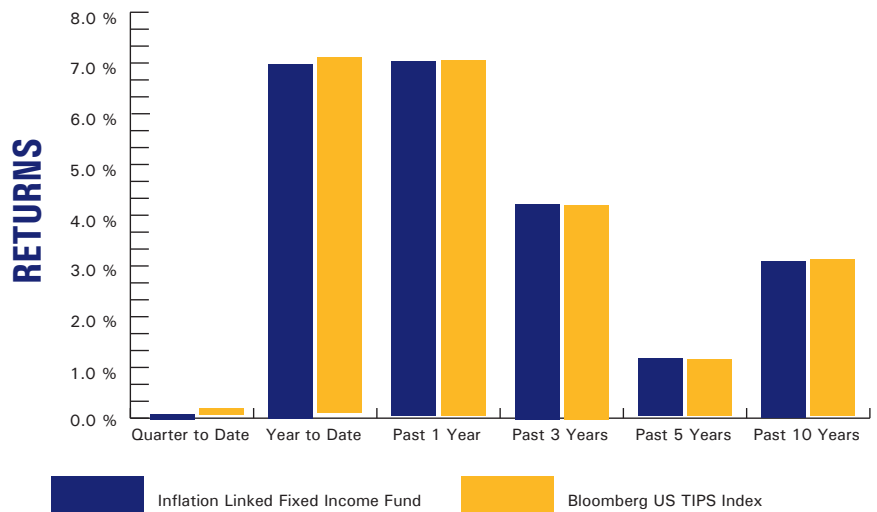

Fund performance is net of fees. Underlying managers, strategies, and target weights can change over time. The Inflation Linked Fixed Income Fund's historical underlying construction includes:

- 100% Northern Trust TIPS Index Fund since 2/1/2019.
- 100% BlackRock TIPS Index Fund from 5/22/2018 to 1/31/2019.
- 100% BlackRock (active) TIPS Fund from 5/21/2018 and prior.

As of 5/22/2018, the Inflation Linked Fixed Income Fund moved from an active to a passive investment management style.
