6) LEGISLATION:

A) 1993 Proposed C.R. 26: Landis submitted a proposed draft as a springboard for board discussion. Landis met with CJ Shepherd on 12/17/92 and was told that Shepherd wants info from all counties re indigent defense expenditures, numbers of caseloads, investigators, etc. Shepherd is trying to determine if more than Marion and Lake need a Supreme Court rule re minimum standards, and what the details of the rule should be. The Board approves statewide need for minimum standards and will promulgate a proposed Rule 26 by late March. Landis asks that we assist in collection of relevant data, as well as anecdotal info from our home counties.


