Bond on a new arrest shall not be set for any person who is wanted on a criminal warrant in another matter in this or any other jurisdiction until Initial Hearing. All bonds for offenses on this schedule may be posted at 10% cash deposit for the amount of the highest single charge alleged. Bond in all other offenses will be set at the time of finding of Probable Cause and/or at the Initial Hearing in Court.

In cases concerning crimes of violence when bond is set and posted, the Jailer shall notify the alleged victim **prior to release** as required by the Crime Victim Notification Statute (I.C. 35-33-12 et.seq.). The arresting agency shall supply victim contact information to the Jail Officer on duty for the notification to be made. A person arrested for a crime of Domestic Violence (as described in I.C. 35-41-1-6.3) shall not be released until at least 8 hours after the time of arrest.

Any person charged with an alcohol-related offense (*) and/or exhibiting signs of alcohol intoxication shall not be released until a sufficient time has elapsed to allow that person's blood alcohol level to decrease to below 0.05% (see I.C. 35-33-1-6).

ANY Defendant posting bond prior to an Initial Hearing shall be and hereby is ORDERED to appear in open court at 9:00 AM on the court's next business day.
