1.) Welcome:

 - i.** Completed Projects:
 - 1. Floyd County.** 2 Sites, 5 Channels
 - ii.** Working Projects:
 - 1.** Site Adds

- a. **Porter County** – 5 Site, 12 Channel Simulcast, 700 spectrum. Still working with AT&T on connectivity.
 - i. Connection of their Console system to the P25 core. Connectivity is in and being tested.
- b. **Delphi (Carroll County)**: 1 Site, 5 Channel. Site equipment installed. Antenna work completed.
- c. **Elkhart County**: 5 Site, 12 Channel simulcast in 700 spectrum. – Awaiting DDR.
- d. **Henry County**: 2 Site, 6 Channel. -700 band – Motorola to get customer approval on these sites.
- e. **Brown County**: 1 Site, 5 Channel. – Awaiting approval of the Indian tribes to proceed with tower construction in Bean Blossom. Surveying/Geo study for tower base in process.
- f. **White County**: 1 Site, 6 Channel. – Lake Freeman equipment is being installed and connectivity is on order.

iii. Wireline Console adds

- 1. **Huntington County** – 5-infrastructure is being installed and connectivity is on order

 - a. Data over the Air – Moto P1 CAD statuses, messaging and Emergency locations
 - b. Genesis system to provide push to talk data for Computer Aided Dispatch system.
