
Mississippi River Basin Soil Sampling Program

- Registration for this fall will be open from Tuesday, September 2, 2025, through Friday, October 17, 2025.
 - Prep for the Fall 2025 round of sampling is currently happening to be ready for launch after Labor Day.
- SPRING 2025 Registration Recap:
 - Indiana's Mississippi River Basin (MRB) Soil Sampling Program registration ran open registration this spring from February 24, 2025, through Friday, April 4th, 2025.
 - Spring 2025 Soil Sampling Program Breakdown (these numbers reflect what ISDA staff has worked with, does not include info pertaining to CCA partner work):
 - 135 different landowners/renters registered within the MRB (around 100 registrations in early April).
 - 6,554 acres were registered to be sampled (3,500 acres in early April)
 - To date, over 750 samples pulled by ISDA staff – there are still a few yet to pull, these have been delayed because of either weather conditions and/or landowner preference in wanting to wait until fall.
- The registration process will be the same as it was this spring after some changes were made allowing landowners to digitally identify the acreage they are requesting to be sampled so soil maps can be pulled directly from registration and sent to field staff to allow for more efficient use of field staff time and more precise field locating which were made as a result of feedback from field staff.
- The program acreage enrollment threshold will continue to remain at 100 acres (crop, pasture, hay, specialty) to ensure Resource Specialists are able to maintain workload capacity for other program contributions.
- The program webpage has been updated to reflect program information and can be found on the [ISDA website](#).
- This program includes Indiana watersheds within the MRB and excludes the WLEB and Lake Michigan Basins. This is due to federal statutory language associated with the funds.


Gulf Hypoxia Program (GHP)


- Anticipated upcoming meetings for the GHP CC Taskforce in 2025: late September and early December.
- No-cost extension is being worked on and will be submitted later this year to extend current dollars into Fall of 2026.
- Work for second round of workplan documents was completed early last week as submission was due July 1.
- As a reminder, these are non-competitive funds established under the GHP to allow Hypoxia Task Force Member states to further their nutrient reduction strategy efforts.


Conservation Practices in Northwest

Program Director Activities

FY25 GOAL: Recruit and hire the second cohort (7) Conservation Technicians.

- Six new RITA Techs started last month

ONGOING GOAL: Serve as a liaison for the agreement, and publicize opportunities related to the agreement to SWCDs statewide.

- June and early July were spent coordinating with the SWCDs that are getting the new RITA Techs.

ONGOING GOAL: Facilitate and lead local SWCD Boards, SWCD staff and partners in each program region to ensure effective work assignments and outcomes for Conservation Technicians.

- The quarterly review of RITA Techs by SWCDs for the quarter ending June 30 is currently underway.
 - More than half of the SWCDs have completed the review.
 - The average score is 4.85 on a scale of 1 to 5, where 5 is the best possible score.
 - Comments include:
 - They are always willing to help with any project regardless of its difficulty or mundaneness. They schedule their time with our District around our needs and are always willing to work outside of normal business hours if necessary. They are hardworking, dependable, and excellent communicators. They are always responsive to emails, calls, and texts. They bring an innovative thought process and creative ideas to our District. They really goes the extra mile to help us out.
 - They have been great to work with and an invaluable asset to our small office.
 - So helpful and available when we need. Very knowledgeable.
 - We have been without a District Technician and then hired one and are in the onboarding/training phase. The RITA Tech was able to help familiarize our new District Technician-Technician to Technician instead of Coordinator to Technician regarding various things we do/how we do them/etc. I think this is another reason why this program is a great idea. You have consistent technicians and when other districts bring on a new technician, they are a great source of training/mentoring. I see this program as helpful on many levels. The RITA Techs are continually working to increase their skills then when a SWCD needs help or training or coverage you have someone who can step into that role.

Indiana NRCS State Conservationist Report

July 2025 State Soil Conservation Board Meeting

INDIANA NRCS REORGANIZATION

No update as of July 1, 2025.

FUNDING

Indiana NRCS received an additional \$1.5M for EQIP with preapprovals going out the week of July 1. The priority will be those applications that were previously preapproved/approved in IRA but were not considered in EQIP Classic. Indiana NRCS received an additional \$6M for CSP with preapprovals going out the week of June 23.

FARM BILL PROGRAMS

Environmental Quality Incentives Program (EQIP)

Indiana State office obligated all EQIP-Inflation Reduction Act (EQIP-IRA) applications that had signature dates input in Protracts prior to January 27, 2025. Headquarters gave states instructions on which contracts could be obligated based on information in Protracts and a short timeline to get those contracts obligated.

Conservation Reserve Program (CRP)

The Department announced signups for both Continuous Conservation Reserve Program – including CREP (statewide), SAFE, Highly Erodible Land and Wellhead initiatives – and a General Signup. The signup started on May 12 and runs through July 31.

Regional Conservation Partnership Program (RCPP)

The Southern Indiana Sentinel Landscape's financial assistance has been approved to move forward. INNRCS staff are working with Conservation Law Center to advance current applications towards obligation while minimizing the local workloads.

FOOD SECURITY ACT OF 1985, AS AMENDED, COMPLIANCE REVIEWS

The Indiana NRCS State Office and Area Offices are completing all of the 2025 Food Security Act of 1985, as amended, compliance reviews. The State Office sent letters to the clients who were randomly selected from the national level and last year's variance tracts. Field visits will be completed soon and further data analyses completed from the State Office soon.

CONSERVATION PRACTICE STANDARDS PUBLIC COMMENT PERIOD

A Federal Register Notice for updates to the National Handbook of Conservation Practice Standards was published Monday June 30 and is now open for public comment. The comment period will close on July 30. Practices included are: Access Control (472), Controlled Traffic Farming (Code 334), Irrigation Canal or Lateral (320), Irrigation Ditch Lining (Code 428), Irrigation Field Ditch (388), Open Channel (Code 582), Pest Management Conservation System (595), Pumping Plant (533), Waste Treatment Lagoon (Code 359), Waste Recycling (633), Wildlife Habitat (645)

RESILIENT INDIANA AGREEMENT

Resilient Indiana (RITA) **hired five new regional staff**, bringing the total up to 12 technical staff. RITA Technicians are currently assisting field offices that have limited NRCS staff. The ASTC-Partnerships and State Resource Conservationist are developing additional opportunities for RITA technicians to assist at the field level.
