Mississippi River Basin Soil Sampling Program

- HaPpY NeW YeAr!
- The registration process is currently being reviewed with considerations of making changes prior to Spring 2026 Open Registration – conversations are occurring now about this, will update when more is known.
 - Spring 2026 Open Registration looks to start mid-February and go through early April.
- The program acreage enrollment threshold is set to at 100 acres (crop, pasture, hay, specialty) for the Spring 2026 Open Registration to ensure Resource Specialists are able to maintain workload capacity for other program contributions.
- The program webpage has been updated to reflect program information and can be found on the [ISDA website](#).
- This program includes Indiana watersheds within the MRB and excludes the WLEB and Lake Michigan Basins. This is due to federal statutory language associated with the funds.
- Spring 2026 registration season will be the last registration round under Workplan #1 which means that current program requirements and eligibility will still be in place.

Gulf Hypoxia Program (GHP)

- The GHP CC Taskforce Meeting that was set for the first week of December was postponed due to the federal government shutdown.
 - This meeting has been rescheduled to the first week in February.
- The GHP Annual Report that was due by December 31, 2025 was successfully completed and submitted to EPA on December 23, 2025.
- No-cost extension was approved which means current dollars are extended through spring/summer of 2026.
- Workplan #2 has been approved and is set to start Fall 2026.
 - As a reminder, these are non-competitive funds established under the GHP to allow Hypoxia Task Force Member states to further their nutrient reduction strategy efforts.

By the Numbers

Despite staff furlough resulting from delays in agreement payments and a 6-week federal government shut-down, *in 2025, CCSI was materially involved in over 100 Soil Health events and trainings, reaching approximately 9100 individuals.* Since 2011, CCSI has:

- Participated in nearly 1080 Soil Health events
- Reached approximately 76,650 attendees
- Provided Soil Health training to 1210 unique individuals, many of whom attended multiple trainings

Staffing

- *Soil Health Agronomist*
Sarah Brackney joined the CCSI team as a Soil Health Agronomist on February 3, 2025. Brackney had been serving as the Daviess County Ag and Natural Resources Extension Educator. Because of ongoing budget constraints within Purdue Extension, Brackney continued to provide services as Daviess County Extension Educator
- *Equipment and Machinery Specialist*
Purdue Ag and Biological Engineering posted a position as an Assistant Clinical Professor of Machine Systems for Climate Smart Crop Production. When the position is filled, this individual will be expected to teach and develop courses in the ABE department related to agricultural machinery and equipment for regenerative and climate smart agriculture cropping systems, precision agriculture, digital agriculture, and data science applications in agriculture. They will work closely with the CCSI team, providing outreach on similar topics to farmers and conservation partners. They will also work with the Purdue On The Farm (POTF) team with their on-farm trials and with Purdue Ag Center Superintendents on their equipment set-up.

Jimmy Emmons and Erin Martin “Road Trip”

Using CCSI contacts, Oklahoma Rancher Jimmy Emmons and Gerontologist Erin Martin made a trip to Indiana in January for the IASWCD Annual Conference to talk on Food as Medicine. Taking advantage of their presence, CCSI arranged events outside of the Annual Conference as well. During their short stay, Jimmy and Erin:

- Presented at the IASWCD General Session as well as a Break-out Session
- Met with representatives from Indiana Department of Health, ISDA, NACD, the SSCB, and farmers about an Indiana Food as Medicine program.
- Met with a group of farmers in a roundtable at Rulon Farms to discuss regenerative ag systems and their work in OK.

FFA Convention / Fair Oaks Farm

Jessica Hoehn, Program Manager (and former ag teacher), volunteered to serve as a judge during the convention as federal staff were not allowed to attend as representatives of their agencies.

Rather than step in as a judge Bryan Overstreet, CCSI-POTF Agronomist and Soil Health Specialist, conducted soil health demonstrations for FFA Convention Attendees – students and advisors. Final count has not been completed, but approximately 400-500 attendees interacted with the demonstrations each day. Advisors gathered information on conducting similar demonstrations in their home locations. In addition, Fair Oaks Farm staff were deeply engaged with demonstrations, gathering their own samples to “see how they would perform”. At least one 2026 event is being planned at Fair Oaks that will highlight impacts of soil health practices. Note the imagery is from all three days. Upon recommendations from a CCSI team chat to “see what it will do” the day 1 healthy soil slake demo was left for all three days. It was a sandy loam from Jasper County. Although some soil settled to the bottom of the tube, very little did – demonstrating how healthy soils maintain aggregation, are less susceptible to erosion, and have higher precipitation infiltration capabilities.



Bison-related Event

White Oaks Bison Farm in Fulton County hosted a grazing event for bison growers that focused on grazing pastures and soil health. Jason Tower, Southern Indiana Purdue Ag Center spoke on grazing management with cool season pastures and native grasses; Chris Gardener, ISDA spoke on soil health principles and testing; White Oaks Owner, Terry Engstrand helped attendees understand how to collect hay samples and interpret lab results.

Organic Events

As part of support for Yichao Rui, Purdue University's, Indiana Organic Network project, CCSI provided support for outreach events – one on grazing and one on crop production. Both events were heavily attended by those interested in farming organically in a way that promotes soil health.

Grazing Events

Of note in 2025, events that had a strong grazing component tended to be very well attended with highly engaged audiences. It is unknown whether this is an aberration due to beef pricing or a trend due to a desire to add livestock to soil health systems is unknown at this time.

Trainings

Travel restrictions for Indiana Conservation Partner staff, especially federal staff, significantly impacted their ability to attend in-person trainings. Where possible for single day events, agendas were tightened to help accommodate single day-of-work travel requirements.

- **Introduction to Soil Health**

Held the last Tuesday in February, the virtual Introduction to Soil Health had Fundamentals of Soil Health the 46 attendees included SWCD, NRCS, Purdue Extension, ISDA, Missouri State University, Ohio State University, ag retail, farmers, and one individual from South America

- **Fundamentals of Soil Health**

The Fundamentals of Soil Health series kicked off on April 1st with 52 registrants, including a near-full in-person session. Registrants include SWCD, NRCS, Purdue Extension, ISDA, IDNR, and RITA staff as well as individuals from Missouri State University, Michigan State University, Ohio State University, ag retail, NGOs, and an individual from Argentina.

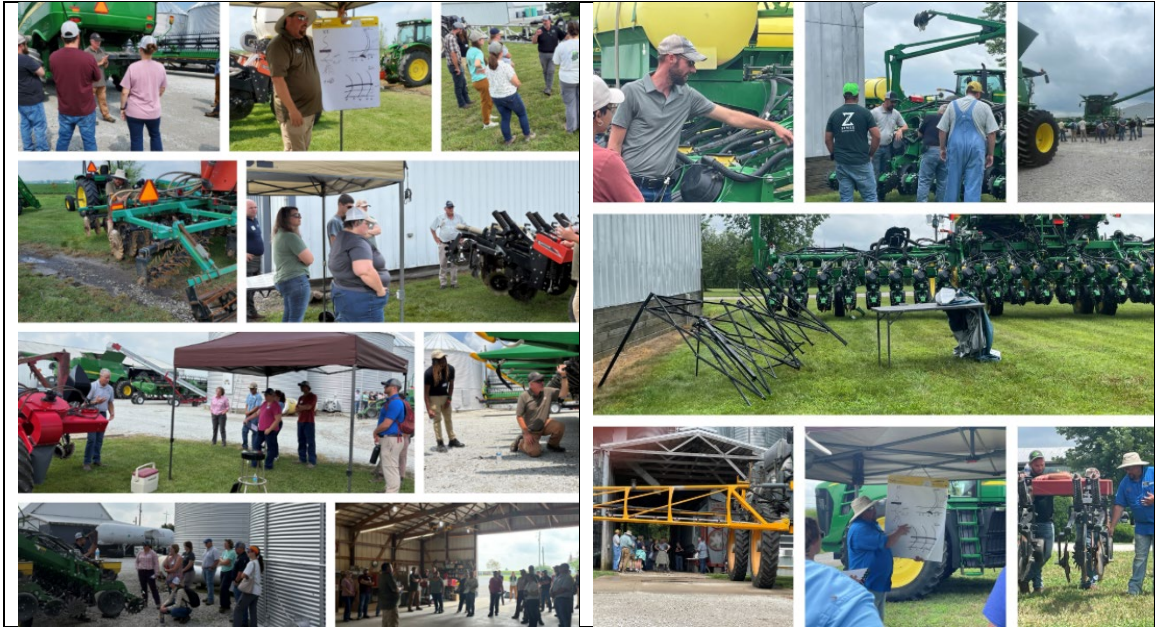
- **CCSI-SARE Soil Health and Sustainability for Field Staff**

This training that satisfies NRCS requirements for conservation planning certifications was the most impacted by travel restrictions. USDA staff were required to drive and return back to the office *each day* of training. The 22 attendees, included 4 NRCS staff, 7 SWCD, 6 RITA, 4 Purdue Extension, and 1 DNR

- **CCSI-SARE Continuing Education: Machinery and Equipment Set-up**

July 14th – Clint Orr Farms, Frankfort / July 16th – Brian and Ben Thompson Farm,

Seymour, The trainings were well sized for machinery demos (approx. 110 ttl), and both received very good feedback from attendees, including the 7/16 event that required adaptation to an intense storm in the morning. Due to the apparent need, these trainings will be repeated in 2026.



- **Purdue On The Farm-SARE Ag 101: Commodity Crop Production**

This training in particular was affected by travel restrictions – in 2024, FSA leadership indicated a desire to have all staff attend this type of training; in 2025 travel restrictions were tougher for FSA staff than NRCS staff.

Approximately 95 attendees over 3 separate trainings. All sessions received good feedback, especially growth staging of corn and soybeans, equipment, and basic in-field use of Corn/Soybean Field Guides in crop scouting.

An Ag 101: Livestock (probably beef) Production is being considered for 2026

- **Conservation Drainage Training**

Originally scheduled for 11/03/25, this training was postponed due to the federal government shutdown. An alternate date will be selected, most likely in March before planting.

Funding

- **Cargill Success from the Ground Up**
CCSI received notification in March that the Cargill Success from the Ground Up program wished to award CCSI a \$50,000 grant for “farmer-facing” type event support. An award letter and grant agreement were executed by the IASWCD.
- **NRCS 2020-25 Agreement**
A re-allocation of funds for the 2020-25 NRCS Agreement was approved. After

June invoicing, provided approximately \$60,000 for training and event support for CCSI.

- Indiana Corn Marketing Council / Indiana Soybean Alliance
ICMC/ISA awarded CCSI \$50,000 for Soil Health Outreach and Education Support

FarmAdvisors Mentoring Program

- FarmAdvisors were notified that they were approved for a National Fish and Wildlife Federation grant of approximately \$500,000.
- The FarmAdvisors Board of Directors assigned board members Cameron Mills and Dan DeSutter to lead both the Mentor-Mentee Matching and Mentor Vetting committees. They are concentrating on surveying mentee needs and mentee interview questions to identify gaps in mentor specialties.
- Born out of November 2024 meeting - which Lisa Holscher, CCSI Director and Dan DeSutter, Farm Advisors Board Member participated – STEP up for Agriculture was officially launched in September. Leading food and retail companies, including PepsiCo, Unilever, General Mills, Starbucks and Nestle launched STEP-up to expand regenerative farming by strengthening farmer-facing organizations. The collaboration provides local groups with essential training tools and funding to help them guide farmers to regen ag practices. *Farm Advisors was selected as one of three key programs to receive initial funding from the group.*

Report to the State Soil Conservation Board

January 13, 2026

Program Director Activities

ONGOING GOAL: Serve as a liaison for the agreement, and publicize opportunities related to the agreement to SWCDs statewide.

- The RITA in Action essays in IASWCD's Conservation INsight newsletter have continued.
 - The essays spotlight what the RITA Techs are doing.
 - Feedback from SWCD staff is that they appreciate the essays
 - The December 24, 2025, essay was a year-end report
- We are interviewing to fill the remaining Tech position.

ONGOING GOAL: Facilitate and lead local SWCD Boards, SWCD staff and partners in each program region to ensure effective work assignments and outcomes for Conservation Technicians.

- We are currently collecting the quarterly review of RITA Techs by SWCDs for the quarter ending December 31. We ask all SWCDs to respond by January 16.
 - 65% of the 65 hosting SWCDs completed the review
 - 66% of the 12 Events Only SWCDs completed the review (optional)
 - The average score was 4.72 on a scale of 1 to 5, where 5 is the best possible score. This is an increase from last quarter.

ONGOING GOAL: Work with NRCS program contact and qualified professionals to ensure the work identified in this agreement progresses as planned and meets technical standards and requirements.

- Leader met with Jerod Chew and Shannon Zezula, NRCS, on January 5, 2026, to discuss training plans for 2026. We anticipate the first training to take place later this month, with more to follow.
