To qualify for the award, the active farm must currently be at least twenty (20) acres, or if the active farm is less than twenty (20) acres, the active farm must gross at least \$1000 a year.

Please include with this application:

1. The completed table below beginning with the original family owner and continuing to the present owner(s).
2. A document illustrating each transfer of ownership. The copy may be either of an original instrument, records maintained in a courthouse, or the page(s) from an abstract of title covering the real estate. The copies must demonstrate an unbroken familiar chain-of-title from the date that a member of your family originally acquired an interest in the real estate to the present.
3. A copy of the most recent property tax bill showing taxes are current.

Return completed application and documentation to the agency at the above address.

* If your family has received the Centennial or Sesquicentennial Award before, you only need to supply ownership information for the changes in ownership that have occurred since the date the farm was last awarded a Hoosier Homestead Award to the present owner.

** If less than twenty (20) acres of original acquisition are retained, please provide documentation of the retained acres' annual farm income.

Please Note: The deadline for the March ceremony is November 1, and the deadline for the August ceremony is April 1.
