II. Discussion

- a. Opening Remarks by Ray Chattin, SSCB Chairman
- b. Review & Revise 5 Priorities
 - i. Item 1: Engage Supervisors to be effective leaders in their communities at the state level.
 - 1. Discussion on the end of leadership institute (LI)
 - a. LI ended due to lack of interest and low registration.
 - 2. Discussion on the Board Certification Program
 - a. Largely stood up through IASWCD & ISDA.
 - i. This program is still in draft form, but will debut in some form at 2024 IASWCD Annual Conference
 - ii. Discuss BCP at SSCB meeting in July
 - 1. Provide materials in advance.
 - 2. Discuss how we might incentivize supervisors to attend trainings/events/be more involved
 - 3. Discussion on engaging supervisors
 - a. SSCB needs to establish higher level role and provide actionable steps and guidance for other conservation entities
 - b. How do we support districts in a way that promotes GROWTH of the district longterm to be more self sustainable
 - 4. Need to identify which pieces of SSCB Plan of Work may be better suited for other conservation orgs, i.e. IASWCD, SWCDs, non-traditional entities
 - ii. Item 2: Increase local SWCD Capacity to be effective partners in ICP & cons. Delivery

- 3. Needs discussion
 - a. Administrative assistance vs technical assistance
 - i. Can't go after CWI without administrative assistance
 - ii. Will match solve this?
- 4. Leveraging is important, but need to assist with narrative beyond leveraged dollars and loads reduced.
- iii. Item 3: Keep elected officials, locals to state, informed on conservation progress
 - 1. Soil loss averages and consideration for other key metrics to tell the story
 - a. Find Total Soil Loss Averages by county via Science Assessment
 - i. Total soil loss and dollars tied in
 - 2. ISDA provides county level conservation reports
 - a. Consider bringing these reports for respective SSCB counties next meeting
 - 3. SSCB "State of the State" report could be lifted, ISDA should provide chair with materials to give a proper state of the state.
 - 4. Discussion on Science Assessment
 - a. Need to properly brief SSCB on Science Assessment
 - b. Namely progress reports and clearer goals
- iv. Report to IN progress and concerns for the priority natural resources concerns
 - 1. Elevate board status and be more public facing
 - 2. We need a picture of the board! Aim For January
 - 3. Work with Regan to complete a Clean Water Indiana press release.
- c. Clean Water Indiana Grants
 - i. CWI Guidance is out how do we further promote?
 - ii. We should not shy away from engaging non-traditional partners, beyond SWCDs and typical awardees.
 - 1. There are groups of conservation organizations out there that can bring new ideas into the fold
 - a. Ducks Unlimited, Pheasants Forever, Land Trusts, etc
 - 2. Keep an eye on Watershed Development Commissions
 - a. Potential to stretch CWI and make SWCDs and our work central to the work in flood and water control
 - 3. For existing guidance we need to encourage districts to apply and apply for **what they need**.
 - a. No partial funding this round
 - b. Write Letter from SSCB to Districts
 - iii. We want CWI to prop up long term functionality of districts
 - 1. Build capacity
 - a. Every district should have administrative support covered bare minimum
 - iv. Consideration for guaranteed 3 year match on a position IF the county puts up.
 - 1. How do we pressure the hinges on counties?

- 2. Consider \$75,000 available per district
 - a. 25,15,10 (year 1,2,3)
- 3. Consider implementation of matching calculations



- 4. Talent pipeline
- d. Future Discussions:
 - i. Aim to hold a **four hour** session on just CWI funding for CWI 2025. There is a need to start communicating NOW on next year.

a. Meeting is not called to order as there will be no formal board action today.

II. Discussion on CWI communication strategy

- a. Recap of last meeting action items
- b. Open Discussion on CWI 2024
 - i. Communication improvements needed
 - 1. Draft letter ahead of July 18th SSCB Meeting
 - a. Communicate the following:
 - i. Note on realistic dollar figures in applications
 - ii. Re-iterate lead on multiple grants
 - iii. Mention survey efforts and feedback
 - 2. include link to budget table.
- c. Discuss CWI Press Release ahead of August, soon after July 18th SSCB Meeting
- d. Letters received from districts regarding CWI match and use of CWI funds

III. Discussion on District Staffing

- a. Board's role is not to carry districts, but to lead and support
 - i. What come's first, the staff or the dollars?
 - ii. Discussed potential CWI 2025 application types
 - 1. Idea for an easier staffing application
 - a. CWI Competitive for programmatic pieces, CWI staffing for staff?
 - b. Idea for tiered staffing grant designed to taper off if funded for second time.
 - i. Incentivize county relationship development.
 - 1. Ex. Y1 75,000, Y2 50,000, Y3 25,000

IV. Discussion on SWCD board training

- a. Board certification program, and what an incentive to meet a "standard of excellence" might look like?
 - i. Is this a job for IASWCD? SSCB? IDEA?
 - 1. IASCWD & ISDA already working on BCP
 - 2. Share information about BCP at July 18th SSCB meeting
 - ii. As BCP is completed, and content gathered would it makes sense to provide a financial incentive using CWI?
 - 1. i.e. structure similar to PARP points
 - a. a part of non-statutory \$10,000 match eligibility
 - 2. Look into the goodyear evaluation process as potential example

V. Lifitng Districts & Board Status through District Showcase awards

- a. Get back to holding SSCB meeting at district showcase winner
- b. Chair give state of the state address.
 - i. Always inspiring to see how creative and capable districts are

VI. Discussion on additional \$10,000 or future match

- a. Ohio has a formulaic way of calculating what match goes where
 - i. Equitable
 - 1. Tailored to give districts with low/no local funding a higher rate of match (200%)
 - 2. Sets a % cap for districts with high levels of local/other funding, but doesn't disincentivize as districts bring in more funds, even a small % match still garners a significant state investment
 - a. Ex. County x only has \$10,000 but matched at 200%
 - i. \$30,000 total
 - b. Ex. County has \$100,000 and is min match cap threshold only matched at 20%
 - i. \$120,000
- b. Idea for a match request form that defines what additional match may be used for and asks for what it will be used for.
 - i. 10k guaranteed by statute
 - ii. 10k requested
 - iii. X dollars for supervisor engagement or hitting "standards of excellence"
- c. AFR data can play a role in decision making process as well
- d. Reviewed AFR data

VII. Discussion on Lifting SSCB, being more engaged.

- a. Strategic Planning Sessions help tremendously with creative and innovative ideas.
- b. Board does sessions at IASWCD, should board present at IDEA?
 - i. Are there other conferences, events that the board needs better representation at?
- c. Utilize board platform to celebrate conservation
 - i. i.e. send congratulatory letters
 - 1. Master Gardner's?
