- I. **Call to Order: 9:02 by Gene Schmidt**
- II. **Approval of Minutes of October 21, 2025**

Jane Hardisty moved to approve minutes. Brad Dawson seconded. Jeff asked that minutes be reviewed and edited. Discussion was to review those changes and review edited minutes at January meeting. Motion was then made by Jeff to table minutes approval until they were edited. Jewell seconded. Board voted unanimously to edit minutes, review, and possibly approve at January meeting.

- III. **Clean Water Indiana**

Jennifer Thum gave the CWI Report for Tara Wesseler-Henry. Grant committee met and had a successful meeting earlier this month. Grant reviews are almost

complete. One review is left to complete for 2025. Capacity reports are currently being submitted. These reports will summarize how CWI funds are being used around the state. Grant writing training is being developed currently. Jane Hardisty asked about discussing CWI grants in the future with the board to get thoughts on current grant requests and active grants to see if CWI funding is being used as the board desires. Jane Hardisty also asked about the capacity reports. She was hoping to see a summary of how all CWI funds are currently being used and spent around the state. The board requested to review CWI funding in January. Breegan Anderson summarized how the request for information or request for proposals works since there were some changes in administrative policies for some programs.

#### **IV. State Soil Conservation Board Business**

- a. Each board member took turns to speak on SSCB activity since last meeting.
  - a. Kenny Cain started and summarized his work as a member of the CCSI Steering Committee.
  - b. Chris Lee attended a market ready meeting, a Purdue Extension event.
  - c. Jeff Healy met with Jennifer Thum to learn more about the budget and how that process works.
  - d. Jewel Wise attended the SNE Region Meeting at Red Gold. She enjoyed seeing what goes into the process of tomato production in Indiana.
  - e. Brad Dawson met with CWI committee.
  - f. Jane Hardisty was asked to speak at an annual meeting on February 24.
- b. SSCB Training
  - Some training for State Soil Conservation Board members is needed. This will need to be completed at a board meeting to observe open door laws.
- c. SWCD concerns
  - Topics of data centers, solar farms, and water quantity are big issues around the state. Districts are forced to deal with these issues consistently. Jane Hardisty was wondering if any information needs to be given to the districts to help them be better prepared for issues surrounding these topics. Gene Schmidt said he attended the South-Northwest meeting. Some concerns regarding the conservation impact on resources following land use change was one of Genes' biggest takeaways from the meeting. Districts need to be provided with the best possible information to help guide local decision

makers when these changes take place. Jane Hardisty also mentioned that NRCS has announced some of their changes in alignment. Gene Schmidt doesn't believe that we can accumulate enough information as fast as we need it across the state, so he requests District Support Staff make State Soil Board Members aware of issues as they arise, so they help districts guide through challenges.

d. Division of Soil Conservation Director's Report

Jennifer gave director's report. Report was handed out and made available, and she also summarized the report. Jennifer also handed out the current working budget for the board to review. Details are provided and Jennifer and Jeff will work through the details. Jennifer also discussed the issue of term limits. She is getting more details from Jonathon. He will work with the board on their terms. Breegan Anderson summarized details on a district capacity needs assessment. The Division of Soil has reached out to different agencies that can do this and have found a bid that works. They are hoping this will get things rolling with this group soon.

e. ISDA continues to work with IDEA on a marketing video. Jennifer gave an update on the status of that video.

**V. Soil and Water Conservation Districts**

- a. Cass County SWCD: Sandra Hoffarth gave details on resignation in Cass County. Details on a temporary supervisor appointment in Cass County was provided to the board.
