AFFECTED PRODUCT: Sweet Butternut Squash Ravioli and Meijer frozen Butternut Squash Ravioli

SUMMARY: Unclassified Recall; The recall has been initiated because the products may contain undeclared cashew and almond.

Bertagni product is packaged in a paper tray inside a plastic bag and wrapped around with paper band, and was distributed nationwide between 5/11/15 and 11/12/15. The affected lot code can be found on the front of the Bertagni package

Meijer product is packaged in a paper box and was distributed in Illinois, Indiana, Michigan, Ohio, and Wisconsin between 6/12/15 to 10/26/15. The affected lot code can be found on the side panel of Meijer package.
