RE: Variance Request # 742014

On July 28, 2014, this office received a request from Udilfido Serrano Miranda to vary section 269 of 410 IAC 7-24, "Retail Food Establishment Sanitation Requirements," relating to the requirements for certain warewashing equipment at the Latina America Meat Market, New Albany, IN. After a discussion with Julia Hayes, Floyd County Health Department, it has been determined that the facility does not prepare or otherwise handle food which is not prepackaged and has no operational need for warewashing equipment. Under these circumstances, a three compartment sink is not required to be installed. This will be re-evaluated in the future by the local health department should the menu change. This additional information negates the need for a variance.

If you wish to request an administrative review or stay of effectiveness of this decision pursuant to Ind. Code §40-21.5-3-7(a), you must petition for such review in writing. The petition must state facts demonstrating that:

- a. you are a person to whom the decision is specifically directed;
- b. you are aggrieved or adversely affected by the decision; or,
- c. you are entitled to review under any law.


